

# SENATE BILL NO. 577

June 24, 2021, Introduced by Senators WOJNO, OUTMAN, ANANICH and BULLOCK and referred to the Committee on Regulatory Reform.

A bill to amend 1971 PA 79, entitled  
"Age of majority act of 1971,"  
by amending section 3 (MCL 722.53).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:
