SENATE BILL NO. 200**

A bill to amend 1979 PA 94, entitled  
"The state school aid act of 1979,"  
by amending sections 236 and 241 (MCL 388.1836 and 388.1841),  
section 236 as amended by 2022 PA 212 and section 241 as amended by  
2022 PA 144.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 236. ~~(1)~~—Subject to the conditions set forth in this  
2 article, the amounts listed in this section are appropriated for  
3 higher education for the fiscal year ending September 30, ~~2023,~~  
4 **2024**, from the funds indicated in this section. The following is a

4       Sec. 241. (1) Subject to sections 244 and 265a, the funds  
5 appropriated in section 236 to public universities must be paid out  
6 of the state treasury and distributed by the state treasurer to the  
7 respective institutions in 11 equal monthly installments on the  
8 sixteenth of each month, or the next succeeding business day,  
9 beginning with October 16, ~~2022.~~**2023**. Except for Wayne State  
10 University, each institution shall accrue its July and August ~~2022~~  
11 **2024** payments to its institutional fiscal year ending June 30,  
12 ~~2023.~~**2024**.

13       (2) All public universities shall submit higher education  
14 institutional data inventory (HEIDI) data and associated financial  
15 aid program information requested by and in a manner prescribed by  
16 the state budget director. For public universities with fiscal  
17 years ending June 30, these data must be submitted to the state  
18 budget director by October 15 of each fiscal year. Public  
19 universities with a fiscal year ending September 30, ~~2022.~~**2023**  
20 shall submit preliminary HEIDI data by November 15, ~~2022.~~**2023** and  
21 final data by December 15, ~~2022.~~**2023**. If a public university fails  
22 to submit HEIDI data and associated financial aid program  
23 information in accordance with this reporting schedule, the state  
24 treasurer may withhold the monthly installments under subsection  
25 (1) to the public university until those data are submitted.
