Sec. 201. In accordance with section 30 of article IX of the state constitution of 1963, for the fiscal year ending September 30, 2025, total state spending under part 1 from state sources is \$422,422,900.00 and state spending under part 1 from state sources

1 to be paid to local units of government is \$11,252,900.00. The

20 Sec. 202. The appropriations under this part and part 1 are  
 21 subject to the management and budget act, 1984 PA 431, MCL 18.1101  
 22 to 18.1594.

23 Sec. 203. As used in this part and part 1:

24 (a) "Department" means the department of natural resources.

25 (b) "Director" means the director of the department.

26 (c) "FTE" means full-time equated.

27 (d) "IDG" means interdepartmental grant.

28 (e) "Standard report recipients" means the senate

29 appropriations subcommittee on agriculture and natural resources,

1 the house appropriations subcommittee on agriculture and rural  
2 development and natural resources, the senate and house fiscal  
3 agencies, the senate and house policy offices, and the state budget  
4 office.

5 Sec. 204. The department shall use the internet to fulfill the  
6 reporting requirements of this part. This requirement includes  
7 transmitting reports to the standard report recipients by email and  
8 posting the reports on an internet site.

9 Sec. 205. To the extent permissible under section 261 of the  
10 management and budget act, 1984 PA 431, MCL 18.1261, all of the  
11 following apply to the expenditure of funds appropriated in part 1:

12 (a) The funds must not be used for the purchase of foreign  
13 goods or services, or both, if competitively priced and of  
14 comparable quality American goods or services, or both, are  
15 available.

16 (b) Preference must be given to goods or services, or both,  
17 manufactured or provided by Michigan businesses, if they are  
18 competitively priced and of comparable quality.

19 (c) Preference must be given to goods or services, or both,  
20 that are manufactured or provided by Michigan businesses owned and  
21 operated by veterans, if they are competitively priced and of  
22 comparable quality.

23 Sec. 206. The department shall not take disciplinary action  
24 against an employee of the department for communicating with a  
25 member of the legislature or legislative staff, unless the  
26 communication is prohibited by law and the department is exercising  
27 its authority as provided by law.

28 Sec. 207. Consistent with section 217 of the management and  
29 budget act, 1984 PA 431, MCL 18.1217, the department shall prepare

1 a report on out-of-state travel expenses not later than January 1.  
2 The report must list all travel by classified and unclassified  
3 employees outside this state in the previous fiscal year that was  
4 funded in whole or in part with funds appropriated in the  
5 department's budget. The department shall submit the report to the  
6 standard report recipients and to the senate and house  
7 appropriations committees. The report must include all of the  
8 following information:

9 (a) The dates of each travel occurrence.

10 (b) The total transportation and related expenses of each  
11 travel occurrence and the proportions funded with state general  
12 fund/general purpose revenues, state restricted revenues, federal  
13 revenues, and other revenues.

14 Sec. 208. The department shall not use funds appropriated in  
15 part 1 to hire a person to provide legal services that are the  
16 responsibility of the attorney general. This section does not apply  
17 to legal services for bonding activities or to outside legal  
18 services that the attorney general authorizes.

19 Sec. 209. Not later than December 15, the state budget office  
20 shall prepare and submit a report that provides estimates of the  
21 total general fund/general purpose appropriation lapses at the  
22 close of the previous fiscal year. The report must summarize the  
23 projected year-end general fund/general purpose appropriation  
24 lapses by major departmental program or program areas. The state  
25 budget office shall submit the report to the standard report  
26 recipients and to the chairpersons of the senate and house  
27 appropriations committees.

28 Sec. 210. In addition to the funds appropriated in part 1,  
29 there is appropriated an amount not to exceed \$25,000,000.00 for



1 state restricted contingency authorization. Amounts appropriated  
2 under this subsection are not available for expenditure until they  
3 have been transferred to another line item in part 1 under section  
4 393(2) of the management and budget act, 1984 PA 431, MCL 18.1393.

5 Sec. 211. The department shall cooperate with the department  
6 of technology, management, and budget to maintain a searchable  
7 website accessible by the public at no cost that includes, but is  
8 not limited to, all of the following for the department:

9 (a) Fiscal year-to-date expenditures by category.

10 (b) Fiscal year-to-date expenditures by appropriation unit.

11 (c) Fiscal year-to-date payments to a selected vendor,  
12 including the vendor name, payment date, payment amount, and  
13 payment description.

14 (d) The number of active department employees by job  
15 classification.

16 (e) Job specifications and wage rates.

17 Sec. 212. Not later than 14 days after the release of the  
18 executive budget recommendation, the department shall cooperate  
19 with the state budget office to provide an annual report on  
20 estimated state restricted fund balances, state restricted fund  
21 projected revenues, and state restricted fund expenditures for the  
22 previous 2 fiscal years. The report must be submitted to the  
23 standard report recipients and to the chairpersons of the senate  
24 and house appropriations committees.

25 Sec. 214. (1) Funds appropriated in part 1 must not be used to  
26 restrict or impede a marginalized community's access to government  
27 resources, programs, or facilities.

28 (2) From the funds appropriated in part 1, local governments  
29 shall report any action or policy that attempts to restrict or

1 interfere with the duties of a local health officer.

2       Sec. 215. To the extent permissible under the management and  
3 budget act, 1984 PA 431, MCL 18.1101 to 18.1594, the director shall  
4 take all reasonable steps to ensure geographically-disadvantaged  
5 business enterprises compete for and perform contracts to provide  
6 services or supplies, or both. The director shall strongly  
7 encourage firms with which the department contracts to subcontract  
8 with certified geographically-disadvantaged business enterprises  
9 for services, supplies, or both. As used in this section,  
10 "geographically-disadvantaged business enterprises" means that term  
11 as defined in Executive Directive No. 2019-08.

12       Sec. 216. On a quarterly basis, the department shall report on  
13 the number of full-time equated positions in pay status by civil  
14 service classification, including a comparison by line item of the  
15 number of full-time equated positions authorized from funds  
16 appropriated in part 1 to the actual number of full-time equated  
17 positions employed by the department at the end of the reporting  
18 period. The report must be submitted to the senate and house  
19 appropriations committees and to the standard report recipients.

20       Sec. 217. It is the intent of the legislature that the  
21 department maximize the efficiency of the state workforce, and, if  
22 possible, prioritize in-person work, and post its in-person,  
23 remote, or hybrid work policy on its website.

24       Sec. 219. The department shall receive and retain copies of  
25 all reports funded from appropriations in part 1. The department  
26 shall follow federal and state guidelines for short-term and long-  
27 term retention of records. The department may electronically retain  
28 copies of reports unless otherwise required by federal and state  
29 guidelines.

1           Sec. 220. Not later than April 1, the department shall report  
2 on each specific policy change made to implement a public act  
3 affecting the department that took effect during the previous  
4 calendar year. The department shall submit the report to the  
5 standard report recipients, to the senate and house appropriations  
6 committees, and to the joint committee on administrative rules.

7           Sec. 222. To the extent possible, the department shall not  
8 expend appropriations under part 1 until all existing authorized  
9 work project funds available for the same purposes are exhausted.

10           Sec. 225. Funds appropriated under part 1 or this part **may** not  
11 be used for construction, repair, or remodeling of a building or  
12 structure owned or leased by this state unless the construction,  
13 repair, or remodeling is performed by individuals who have  
14 completed or are enrolled in a registered apprenticeship program,  
15 as that term is defined in 29 USC 50c, that is certified as  
16 approved by the United States Secretary of Labor as described in 29  
17 USC 50c.

18 Sec. 227. Pursuant to section 43703(3) of the natural

 22 the Michigan conservation and recreation legacy fund, \$6,000,000.00

24 Sec. 228. The department may contract with or provide grants  
 25 to local units of government, institutions of higher education, or

9 **COMMUNICATION AND CUSTOMER SERVICES**

10 Sec. 240. (1) In addition to supporting the existing  
11 archeological responsibilities of the department within the  
12 Michigan History Center, the funds appropriated in part 1 for  
13 cultural resource management and cultural resource management one-  
14 time shall be utilized to continue the ongoing process of increased  
15 consultation with known lineal descendants and officials of Native  
16 American tribes on whose aboriginal lands a planned archeological  
17 activity will occur or an inadvertent discovery has been made. The  
18 consultation shall address the identification, treatment, and  
19 disposition of Native American cultural items.

20 (2) The department is encouraged to, whenever possible,  
21 repatriate or transfer from its collections Native American

28 Sec. 251. From the amounts appropriated in part 1 for invasive  
29 species prevention and control, the department shall allocate not

1 less than \$3,600,000.00 for grants for the prevention, detection,  
2 eradication, and control of invasive species.

3 Sec. 252. (1) In addition to the funds appropriated in part 1,  
4 revenue deposited in the invasive species fund created in section  
5 41311 of the natural resources and environmental protection act,  
6 1994 PA 451, MCL 324.41311, is appropriated and may be expended for  
7 invasive species immediate response efforts.

8 (2) The department shall annually notify the house and senate  
9 appropriations subcommittees on natural resources and the house and  
10 senate fiscal agencies of any expenditure of funds appropriated  
11 under subsection (1).

13 **DEPARTMENT SUPPORT SERVICES**

14 Sec. 302. The department may charge land acquisition projects  
15 appropriated for the fiscal year ending September 30, 2025, and for  
16 prior fiscal years, a standard percentage fee to recover actual  
17 costs, and may use the revenue derived to fund the land acquisition  
18 service charges provided for in part 1.

19 Sec. 303. As appropriated in part 1, the department may charge  
20 both application fees and transaction fees related to the exchange  
21 or sale of state-owned land or rights in land authorized by part 21  
22 of the natural resources and environmental protection act, 1994 PA  
23 451, MCL 324.2101 to 324.2165. To the extent consistent with part  
24 21, fees shall be set by the director at a rate that allows the  
25 department to recover its costs for providing these services.

26 Sec. 304. In addition to the funds appropriated in part 1, the  
27 department may receive and expend money from state restricted  
28 sources to pay vendor costs associated with administering sales of  
29 carbon offset credits.

**COMMUNICATION AND CUSTOMER SERVICES**

Sec. 408. By December 1, the department shall submit to the senate and house appropriations subcommittees on natural resources a report on all land transactions approved by the natural resources commission in the prior fiscal year. For each land transaction, the report shall include the size of the parcel, the county and municipality in which the parcel is located, the dollar amount of the transaction, the fund source affected by the transaction, and whether the transaction is by purchase, public auction, transfer, exchange, or conveyance.

**FOREST RESOURCES DIVISION**

Sec. 802. (1) From the funds appropriated in part 1, the department shall, by January 1, prepare and submit to the senate and house appropriations subcommittees on natural resources and the standing committees of the senate and house with primary responsibility for natural resources issues a report on all of the following:

(a) The number of acres of state forestland prepared for timber harvesting in the prior fiscal year.

(b) The number of acres of state forestland timber sold in the prior fiscal year.

(c) The amount of revenue generated by the timber sale and harvesting of state land in the prior fiscal year.

Sec. 803. In addition to the money appropriated in part 1, the department may receive and expend money from federal sources to provide response to wildfires and hazard incidents as required by a compact with the federal government. If additional expenditure

1 authorization is required, the department shall so notify the state  
2 budget office. The department shall notify the house and senate  
3 appropriations subcommittees on natural resources and the house and  
4 senate fiscal agencies by November 15 of the expenditures under  
5 this section during the prior fiscal year.

6 Sec. 807. (1) In addition to the funds appropriated in part 1,  
7 there is appropriated from the disaster and emergency contingency  
8 fund up to \$800,000.00 to cover department costs related to any  
9 disaster as defined in section 2 of the emergency management act,  
10 1976 PA 390, MCL 30.402.

11 (2) Funds appropriated under subsection (1) shall not be  
12 expended unless the state budget director recommends the  
13 expenditure and the department notifies the house and senate  
14 committees on appropriations. By December 1 each year, the  
15 department shall provide a report to the senate and house fiscal  
16 agencies and the state budget office on the use of the disaster and  
17 emergency contingency fund during the prior fiscal year.

18 (3) If Federal Emergency Management Agency (FEMA)  
19 reimbursement is approved for costs paid from the disaster and  
20 emergency contingency fund, the federal revenue shall be deposited  
21 into the disaster and emergency contingency fund.

23 **GRANTS**

24 Sec. 1001. Federal pass-through funds to local institutions  
25 and governments that are received in amounts in addition to those  
26 included in part 1 for grants to communities - federal oil, gas,  
27 and timber payments and that do not require additional state  
28 matching funds are appropriated for the purposes intended. By  
29 November 30, the department shall report to the senate



1 appropriations subcommittee on agriculture and natural resources,  
2 the house appropriations subcommittee on agriculture and rural  
3 development and natural resources, the senate and house fiscal  
4 agencies, and the state budget director on all amounts appropriated  
5 under this section during the prior fiscal year.

7 **CAPITAL OUTLAY**

8 Sec. 1103. The appropriations in part 1 for capital outlay  
9 shall be carried forward at the end of the fiscal year consistent  
10 with section 248 of the management and budget act, 1984 PA 431, MCL  
11 18.1248.

13 **ONE-TIME APPROPRIATIONS**

14 Sec. 1201. (1) From the unexpended and unencumbered funds  
15 appropriated in 2022 PA 166 and 2023 PA 119 for equipment lifecycle  
16 replacement and body cameras for conservation officers, the  
17 following appropriations shall be made:

18 (a) \$3,000,000.00 for Huron Waterloo Pathways Initiative's  
19 Border-To-Border trail.

20 (b) \$1,000,000.00 for Upper Peninsula ski jump project.

21 (c) \$1,000,000.00 for Michigan the Beautiful Initiative.

22 (2) The funds appropriated under subsection (1) are considered  
23 work project appropriations for the fiscal year ending September  
24 30, 2025. Any unencumbered or unallotted funds shall not lapse at  
25 the end of the fiscal year and shall be available for expenditure  
26 in succeeding years. The following is in compliance with section  
27 451a of the management and budget act, 1984 PA 431, MCL 18.1451a:

28 (a) The purpose of the projects are to develop trail networks;  
29 to develop ski jump opportunities; and for staff, research, and

1 data compilation to conserve 30% of state land and water by 2030.

2 (b) The projects will be accomplished by state employees or by  
3 contracts.

4 (c) The total estimated cost of the projects is \$5,000,000.00.

5 (d) The tentative completion date is September 30, 2029.

6 Sec. 1202. The funds appropriated in part 1 for state  
7 employees' retirement system implementation costs must be expended  
8 by the department to cover additional pension-related costs if the  
9 following bills of the 102nd Legislature are enacted into law:

10 (a) House Bill No. 4665.

11 (b) House Bill No. 4666.

12 (c) House Bill No. 4667.
