

**SUBSTITUTE FOR  
HOUSE BILL NO. 5516**

A bill to make appropriations for the legislature, the executive, the department of attorney general, the department of state, the department of treasury, the department of technology, management, and budget, the department of civil rights, and certain other state purposes for the fiscal year ending September 30, 2025; to provide for the expenditure of the appropriations; to provide for the disposition of fees and other income received by the state agencies; and to declare the effect of this act.

10 (ii) "PA" means public act.

11 (jj) "RFP" means a request for a proposal.

12 (kk) "SEIU" means Service Employees International Union.

13 (ll) "SIGMA" means statewide integrated governmental management  
14 applications.

15 (mm) "Standard report recipients" means the senate and house  
16 appropriations subcommittees on general government, the senate and  
17 house fiscal agencies, the senate and house policy offices, and the  
18 state budget office.

19 (nn) "WIC" means women, infants, and children.

20 Sec. 204. A department or agency shall use the internet to  
21 fulfill the reporting requirements of this part. This requirement  
22 includes transmitting reports to the standard report recipients and  
23 any other required recipients by email and posting the reports on  
24 an internet site.

25 Sec. 205. To the extent permissible under section 261 of the  
26 management and budget act, 1984 PA 431, MCL 18.1261, all of the  
27 following apply to the expenditure of funds appropriated in part 1:

28 (a) The funds must not be used for the purchase of foreign  
29 goods or services, or both, if competitively priced and of

1 comparable quality American goods or services, or both, are  
2 available.

3 (b) Preference must be given to goods or services, or both,  
4 manufactured or provided by Michigan businesses, if they are  
5 competitively priced and of comparable quality.

6 (c) Preference must be given to goods or services, or both,  
7 that are manufactured or provided by Michigan businesses owned and  
8 operated by veterans, if they are competitively priced and of  
9 comparable quality.

10 Sec. 206. A department or agency shall not take disciplinary  
11 action against an employee of a department or an agency within a  
12 department for communicating with a member of the legislature or  
13 legislative staff, unless the communication is prohibited by law  
14 and the department or agency is exercising its authority as  
15 provided by law.

16 Sec. 207. Consistent with section 217 of the management and  
17 budget act, 1984 PA 431, MCL 18.1217, each department and agency  
18 receiving appropriations in part 1 shall prepare a report on out-of-  
19 state travel expenses not later than January 1. The report must  
20 list all travel by classified and unclassified employees outside  
21 this state in the previous fiscal year that was funded in whole or  
22 in part with funds appropriated in the department's or agency's  
23 budget. The department or agency shall submit the report to the  
24 standard report recipients and to the house of representatives and  
25 senate appropriations committees. The report must include all of  
26 the following information:

3 Sec. 208. A principal executive department, state agency, or  
 4 authority shall not use funds appropriated in part 1 to hire a  
 5 person to provide legal services that are the responsibility of the  
 6 attorney general. This section does not apply to legal services for  
 7 bonding activities or to outside legal services that the attorney  
 8 general authorizes.

9 Sec. 209. Not later than December 15, the state budget office  
 10 shall prepare and submit a report that provides for estimates of  
 11 the total GF/GP appropriation lapses at the close of the previous  
 12 fiscal year. The report must summarize the projected year-end GF/GP  
 13 appropriation lapses by major departmental program or program  
 14 areas. The state budget office shall submit the report to the  
 15 standard report recipients and the chairpersons of the senate and  
 16 house of representatives appropriations committees.

17 Sec. 210. (1) In accordance with section 352 of the management  
 18 and budget act, 1984 PA 431, MCL 18.1352, which provides for a  
 19 transfer of state general fund revenue into or out of the  
 20 countercyclical budget and economic stabilization fund, the  
 21 calculations required by section 352 of the management and budget  
 22 act, 1984 PA 431, MCL 18.1352, are determined as follows:

13 (2) Notwithstanding subsection (1), there is appropriated for  
14 the fiscal year ending September 30, 2025, from GF/GP revenue for  
15 deposit into the countercyclical budget and economic stabilization  
16 fund the sum of \$0.00.

17 Sec. 211. A department or agency shall cooperate with the  
18 MDTMB to maintain a searchable website accessible by the public at  
19 no cost that includes, but is not limited to, all of the following  
20 for each department or agency:

- 21 (a) Fiscal year-to-date expenditures by category.
- 22 (b) Fiscal year-to-date expenditures by appropriation unit.
- 23 (c) Fiscal year-to-date payments to a selected vendor,  
24 including the vendor name, payment date, payment amount, and  
25 payment description.
- 26 (d) The number of active employees by job classification.
- 27 (e) Job specifications and wage rates.

28 Sec. 212. Not later than 14 days after the release of the  
29 executive budget recommendation, a department or agency receiving



1 appropriations in part 1 shall cooperate with the state budget  
2 office to provide an annual report on estimated state restricted  
3 fund balances, state restricted fund projected revenues, and state  
4 restricted fund expenditures for the previous 2 fiscal years. The

14 of reports unless otherwise required by federal and state  
15 guidelines.

16 Sec. 220. Not later than April 1, a department or agency  
17 receiving appropriations in part 1 shall report on each specific  
18 policy change made to implement a PA affecting the department or

24 Sec. 222. To the extent possible, a department or agency shall

26 authorized work project funds available for the same purposes are  
27 exhausted.

28 Sec. 223. General fund appropriations in part 1 shall not be  
29 expended for items in cases where federal funding or private grant

1 funding is available for the same expenditures.

2 Sec. 224. Funds appropriated in part 1 must not be used by  
3 this state or a department, agency, or authority of this state to  
4 purchase an ownership interest in a casino enterprise or a gambling  
5 operation as those terms are defined in the Michigan Gaming Control  
6 and Revenue Act, 1996 IL 1, MCL 432.201 to 432.226.

7 Sec. 225. (1) If the office of the auditor general has  
8 identified an initiative or made a recommendation that is related  
9 to savings and efficiencies in an audit report for an executive  
10 branch department or agency, the department or agency shall report  
11 within 6 months of the release of the audit on their efforts and  
12 progress made toward achieving the savings and efficiencies  
13 identified in the audit report. The report must be submitted to the  
14 standard report recipients, the chairs of the senate and house of  
15 representatives standing committees on appropriations, and the  
16 chairs of the senate and house of representatives standing  
17 committees with jurisdiction over matters relating to the

8 Sec. 301. (1) In addition to the funds appropriated in part 1,  
9 there is appropriated an amount not to exceed \$750,000.00 for  
10 federal contingency authorization. Amounts appropriated under this  
11 subsection are not available for expenditure until they have been  
12 transferred to another line item in part 1 under section 393(2) of  
13 the management and budget act, 1984 PA 431, MCL 18.1393.

14 (2) In addition to the funds appropriated in part 1, there is  
15 appropriated an amount not to exceed \$750,000.00 for state  
16 restricted contingency authorization. Amounts appropriated under  
17 this subsection are not available for expenditure until they have  
18 been transferred to another line item in part 1 under section  
19 393(2) of the management and budget act, 1984 PA 431, MCL 18.1393.

20 (3) In addition to the funds appropriated in part 1, there is  
21 appropriated an amount not to exceed \$50,000.00 for local  
22 contingency authorization. Amounts appropriated under this  
23 subsection are not available for expenditure until they have been  
24 transferred to another line item in part 1 under section 393(2) of  
25 the management and budget act, 1984 PA 431, MCL 18.1393.

26 (4) In addition to the funds appropriated in part 1, there is  
27 appropriated an amount not to exceed \$50,000.00 for private  
28 contingency authorization. Amounts appropriated under this  
29 subsection are not available for expenditure until they have been

1 transferred to another line item in part 1 under section 393(2) of  
2 the management and budget act, 1984 PA 431, MCL 18.1393.

3 Sec. 302. (1) The attorney general shall perform all legal  
4 services, including representation before courts and administrative  
5 agencies, rendering legal opinions, and providing legal advice to a  
6 principal executive department or state agency. A principal  
7 executive department or state agency shall not employ or enter into  
8 a contract with any other person for services described in this  
9 section.

10 (2) The attorney general shall defend judges of all state  
11 courts if a claim is made or a civil action is commenced for  
12 injuries to persons or property caused by the judge through the  
13 performance of the judge's duties while acting within the scope of  
14 the judge's authority as a judge.

15 (3) The attorney general shall perform the duties specified in  
16 1846 RS 12, MCL 14.28 to 14.35, and 1919 PA 232, MCL 14.101 to  
17 14.102, and as otherwise provided by law.

18 Sec. 303. The attorney general may provide not more than 350  
19 copies of the report required under section 30 of 1846 RS 12, MCL  
20 14.30, on a gratis basis. If the attorney general provides 350  
21 copies of the report on a gratis basis, the attorney general may  
22 sell additional copies of the report. The attorney general shall  
23 not provide gratis copies of the report to members of the  
24 legislature. Electronic copies of biennial reports must be made  
25 available on the department of attorney general's website. The  
26 attorney general shall sell copies of the report at not less than  
27 the actual cost of the report and deposit the money received from  
28 the sales into the general fund.

29 Sec. 304. The department of attorney general is responsible

1 for the legal representation of the law of this state and the legal  
2 representation for state of Michigan state employee worker's  
3 disability compensation cases. The risk management revolving fund  
4 revenue appropriation in part 1 must be satisfied by billings from  
5 the department of attorney general for the actual costs of legal  
6 representation, including salaries and support costs.

7       Sec. 307. (1) In addition to the antitrust enforcement  
8 collections revenues in part 1, not more than \$350,000.00 in  
9 antitrust revenues, securities fraud revenues, consumer protection  
10 or class action enforcement revenues, or attorney fees recovered by  
11 the department of attorney general are appropriated to the  
12 department of attorney general for antitrust, securities fraud, and  
13 consumer protection or class action enforcement cases.

14       (2) Not more than \$1,000,000.00 of the unexpended funds from  
15 antitrust revenues, securities fraud revenues, or consumer  
16 protection or class action enforcement revenues at the end of the  
17 fiscal year, including antitrust funds in part 1, may be carried  
18 forward for expenditure in the following fiscal year.

19       (3) On request, the department of attorney general shall make  
20 available information detailing the amount of revenue described in  
21 subsection (1) recovered by the attorney general and a description  
22 of the source of the revenue and the carryforward amount.

23       Sec. 308. (1) In addition to the funds appropriated in part 1,  
24 not more than \$1,000,000.00 is appropriated from litigation expense  
25 reimbursements awarded to this state.

26       (2) The funds described in subsection (1) may be expended for  
27 the payment of court judgments, settlements, arbitration awards or  
28 other administrative and litigation decisions, attorney fees, and  
29 litigation costs, assessed against the office of the governor, the

1 department of attorney general, the governor, or the attorney  
2 general when acting in an official capacity as the named party in  
3 litigation against this state. The funds described in subsection

14 to 800.406. In addition to the funds appropriated in part 1, if the  
15 department of attorney general collects more than \$1,131,000.00 in  
16 gross annual prisoner reimbursement receipts provided to the  
17 general fund, not more than \$1,000,000.00 of the excess is  
18 appropriated to the department of attorney general and may be spent  
19 on the representation of the MDOC and its officers, employees, and

8 Sec. 310. (1) For the purposes of providing title IV-D child  
9 support enforcement funding, the attorney general shall maintain a  
10 cooperative agreement with the MDHHS, as the state IV-D agency, for  
11 federal IV-D funding to support the child support enforcement  
12 activities within the department of attorney general.

13 (2) The attorney general or the attorney general's designee  
14 shall, to the extent allowed under federal law, have access to any  
15 information used by this state to locate parents who fail to pay  
16 court-ordered child support.

17 Sec. 311. From the funds appropriated in part 1 for  
18 operations, the department of attorney general shall distribute  
19 \$500,000.00 to the Center for Civil Justice. The Center for Civil  
20 Justice shall use the money to do both of the following:

21 (a) Provide legal and technical assistance to low-income  
22 individuals.

23 (b) Pursue impact litigation that protects low-income and  
24 marginalized populations.

25 Sec. 312. The department of attorney general shall not receive  
26 or expend funds, other than those authorized in part 1, for legal  
27 services provided specifically to other state departments or  
28 agencies except for expert witness costs, court costs, or other  
29 nonsalary litigation costs associated with a pending legal action.



1           Sec. 313. The department of attorney general shall submit a  
2 quarterly report on the lawsuit settlement proceeds fund described  
3 in section 33 of 1846 RS 12, MCL 14.33, to the standard report  
4 recipients. Each report must include all of the following:

5           (a) The total amount of revenue deposited in the lawsuit  
6 settlement proceeds fund in the current fiscal year delineated by  
7 case.

8           (b) The total amount appropriated from the lawsuit settlement  
9 proceeds fund in the current fiscal year delineated by  
10 appropriation.

11           (c) Earned settlement proceeds that are anticipated but not  
12 yet deposited in the fund delineated by case.

13           (d) Any known potential settlement amounts from cases that  
14 have not been decided, delineated by case.

15           Sec. 314. (1) The department of attorney general may spend not  
16 more than \$2,661,300.00 of the funds appropriated in part 1 from  
17 the lawsuit settlement proceeds fund for the costs of all  
18 associated expenses related to the declaration of emergency due to  
19 drinking water contamination.

20           (2) The department of attorney general shall submit a  
21 quarterly report to the standard report recipients and to the  
22 senate and house of representatives appropriations committees that  
23 details how the funds in subsection (1) and all other currently and  
24 previously budgeted funds associated with legal costs pertaining to  
25 the declaration of emergency due to drinking water contamination  
26 were expended. The report must itemize expenditures by case,  
27 purpose, hourly rate of retained attorney, and department involved.

28           (3) As a condition of receiving funds appropriated in part 1  
29 from the lawsuit settlement proceeds fund, the attorney general

1 must not retain the services of an outside counsel associated with  
2 the declaration of emergency due to drinking water contamination at  
3 an hourly rate of more than \$250.00 unless all reporting  
4 requirements under subsection (2) are satisfied.

5 Sec. 316. (1) From the funds appropriated in part 1 for sexual  
6 assault law enforcement efforts, the department of attorney general  
7 shall use the funds to test backlogged sexual assault kits across  
8 this state. The funding provided in part 1 must be used for only 1  
9 or more of the following purposes:

10 (a) To eliminate all county sexual assault kit backlogs across  
11 this state.

12 (b) To assist local prosecutors with investigations and  
13 prosecutions of viable sexual assault cases.

14 (c) To provide victim services.

15 (2) Not later than February 1, the department of attorney  
16 general shall submit a report to the standard report recipients.  
17 The report must include all of the following information:

18 (a) The number of sexual assault kits across this state that  
19 remain untested as of January 31, 2025.

20 (b) A detailed work plan that outlines the department of  
21 attorney general's action plan to eliminate all outstanding sexual  
22 assault kits and the time frame for completion of testing of all  
23 untested sexual assault kits.

24 (c) A detailed work and spending plan that outlines  
25 anticipated litigation action and expenditures resulting from  
26 findings of the sexual assault kit testing.

27 (3) Any funds remaining after the department of attorney  
28 general has met the obligations required under subsection (1) may  
29 be used for the purpose of retesting any previously tested sexual

1 assault kits across this state using currently available DNA  
2 testing. Funds may be used under this subsection only for DNA  
3 testing on previously tested kits that were not tested for DNA. If  
4 there are remaining untested sexual assault kits on January 31,  
5 2025, funds appropriated in part 1 must be used only for the  
6 testing of those kits.

7 Sec. 317. (1) The department of attorney general shall submit  
8 a report to the standard report recipients and the state budget  
9 director. The report must include all legal costs and associated  
10 expenses related to the declaration of emergency due to drinking  
11 water contamination and the investigations and any resulting  
12 prosecutions. The state budget director shall include the report in  
13 the Flint water emergency-financial and activities tracking and  
14 reporting document that is posted by the state budget director on  
15 the public website, [https://www.michigan.gov/budget/fiscal-](https://www.michigan.gov/budget/fiscal-pages/reports/flint)  
16 [pages/reports/flint](https://www.michigan.gov/budget/fiscal-pages/reports/flint). The tracking and reporting documents must  
17 include the budget line item source for each expenditure.

18 (2) At the conclusion of all attorney general investigations  
19 related to the declaration of emergency due to drinking water  
20 contamination, all materials related to any investigations shall be  
21 preserved pursuant to applicable document retention policies.

22 Sec. 319. From the funds appropriated in part 1, the attorney  
23 general shall submit a quarterly report on the wrongful  
24 imprisonment compensation fund that includes at least all of the  
25 following:

26 (a) All payments made from the wrongful imprisonment  
27 compensation fund in each prior quarter of the fiscal year, and the  
28 total of those payments, including if each payment is part of a new  
29 settlement or part of an installment plan.

1 (b) Total payments made from each prior fiscal year and the  
2 total of all payments to date.

3 (c) Any settlements that have been decided but have yet to  
4 receive a payment.

5 (d) The number of known cases seeking a settlement, but do not  
6 have a final judgment, and the dollar amount of each potential  
7 payment for these known cases, and the total of these payments.

8 (e) The balance of the wrongful imprisonment compensation fund  
9 at the end of the previous quarter.

10 (f) The percent of claims received in the immediately  
11 preceding fiscal quarter that were awarded compensation.

12 (g) The percent of claims received in the immediately  
13 preceding fiscal year that were awarded compensation.

14 (h) For claims that did not receive the full amount of  
15 compensation sought, both of the following:

16 (i) The amount of compensation that was sought.

17 (ii) The amount of compensation that was received.

18 Sec. 320. (1) From the funds appropriated in part 1, the  
19 department of attorney general shall do all of the following:

20 (a) Not later than 14 days after the settlement of a lawsuit  
21 with a fiscal impact of \$200,000.00 or more, submit a report on the  
22 settlement to the standard report recipients.

23 (b) Enforce the laws of this state.

24 (2) Any proceeds from a lawsuit initiated by or settlement  
25 agreement entered into on behalf of this state against a  
26 manufacturer of tobacco products or manufacturer or distributor of  
27 opioid products by the attorney general are state funds, unless  
28 otherwise directed by a court or legal agreement, and are subject  
29 to appropriation as provided by law.

1           Sec. 321. From the funds appropriated in part 1, the  
2 department of attorney general shall maintain a publicly accessible  
3 internet website dedicated to opioid settlement distributions. The  
4 website must include both of the following:

5           (a) Data on all future funding payable to local units of  
6 government and actual funding received by local units of  
7 government, broken out by case settlement agreement.

8           (b) Other resources that provide information on the opioid  
9 settlement agreements.

10          Sec. 322. (1) Not later than February 1, the department of  
11 attorney general shall submit a report to the standard report  
12 recipients on the cumulative dollar expenditure amount related to  
13 each of the following initiatives and activities of the department  
14 of attorney general for the immediately preceding fiscal year:

15           (a) Catholic church investigation.

16           (b) Elder abuse task force.

17           (c) Conviction integrity unit.

18           (d) Opioid litigation.

19           (e) Hate crimes and domestic terrorism unit.

20           (f) Payroll fraud enforcement unit.

21           (g) PFAS contamination. As used in this subdivision, "PFAS"  
22 means perfluoroalkyl and polyfluoroalkyl substances.

23           (h) Human trafficking.

24           (i) Robocall enforcement.

25           (j) Job court.

26           (k) Organized retail crime unit.

27           (l) Reducing utility rate increases.

28           (m) Boy Scouts of America investigation.

29           (n) Address confidentiality program.

1 (o) Restorative practices.

2 (p) Expungement assistance.

3 (2) For each expenditure required to be reported under  
4 subsection (1), the report must include the dollar amount spent by  
5 fund source.

6 Sec. 324. (1) Not later than September 30, the department of  
7 attorney general must make available to the public on its website a  
8 report on the activities and findings, since April 1, 2019, of the  
9 payroll fraud enforcement unit. The report must include all of the  
10 following:

11 (a) A list of each complaint received by the unit.

12 (b) For each complaint listed under subdivision (a), whether  
13 the attorney general took enforcement action on the complaint and,  
14 if applicable, a description of the enforcement action.

15 (2) If the payroll fraud enforcement unit requests that  
16 another department or agency investigate the validity of a report  
17 received by the unit, or if the unit refers a complaint to another  
18 department or agency, the department of attorney general shall  
19 request the department or agency to report back on the department's  
20 or agency's findings to enable the department of attorney general  
21 to comply with this section.

22

23 **ONE-TIME APPROPRIATIONS**

24 Sec. 330. (1) From the funds appropriated in part 1 for county  
25 prosecutor grants, the department of attorney general shall  
26 distribute grants to the offices of county prosecutors for the  
27 purposes of prosecuting attorney duties. The department of attorney  
28 general shall distribute grants to eligible county prosecutor  
29 offices based on office attorney shortfalls as determined by the

1 Prosecuting Attorneys Association of Michigan, with the goal of  
2 achieving the staffing level of 1,855 hours worked annually per

10 (c) Report the total number of office staff, average caseload,  
11 and local funding by grantee to the Prosecuting Attorneys  
12 Association of Michigan.

13 (3) Not later than February 1, the Prosecuting Attorneys  
14 Association of Michigan shall submit a report to the standard  
15 report recipients and the vice chairperson and minority vice  
16 chairperson of the senate and house appropriations committees that  
17 includes the information listed under subsection (2) (c).

19 **DEPARTMENT OF CIVIL RIGHTS**

20 Sec. 401. (1) In addition to the funds appropriated in part 1,  
21 there is appropriated an amount not to exceed \$1,000,000.00 for  
22 federal contingency authorization. Amounts appropriated under this  
23 subsection are not available for expenditure until they have been  
24 transferred to another line item in part 1 under section 393(2) of  
25 the management and budget act, 1984 PA 431, MCL 18.1393.

26 (2) In addition to the funds appropriated in part 1, there is  
27 appropriated an amount not to exceed \$375,000.00 for private  
28 contingency authorization. Amounts appropriated under this  
29 subsection are not available for expenditure until they have been

1 transferred to another line item in part 1 under section 393(2) of  
2 the management and budget act, 1984 PA 431, MCL 18.1393.

3 Sec. 402. (1) In addition to the appropriations contained in  
4 part 1, the department of civil rights may receive and expend not  
5 more than \$600,000.00 in funds from local sources, private sources,  
6 or both, for all of the following purposes:

7 (a) Developing and presenting training for employers on equal  
8 employment opportunity law and procedures.

9 (b) Publishing and selling civil rights related informational  
10 material.

11 (c) Providing copies of material made available in response to  
12 requests under the freedom of information act, 1976 PA 442, MCL  
13 15.231 to 15.246.

14 (d) Paying other copy fees, subpoena fees, and witness fees.

15 (e) Developing, presenting, and participating in mediation  
16 processes for certain civil rights cases.

17 (f) Providing workshops, seminars, and recognition or award  
18 programs consistent with the programmatic mission of the individual  
19 unit sponsoring or coordinating the programs.

20 (g) Paying staffing costs for all activities included in this  
21 subsection.

22 (2) Not later than November 30, the department of civil rights  
23 shall submit a report to the standard report recipients and the  
24 senate and house of representatives standing committees on  
25 appropriations on the amount of funds received and expended for  
26 purposes authorized under this section.

27 Sec. 403. (1) The department of civil rights may contract with  
28 local units of government to review equal employment opportunity  
29 compliance of potential and existing contractors and may charge for



1 and expend amounts received from local units of government for the  
2 purpose of developing and providing these contractual services.

3 (2) Not later than November 30, the department of civil rights  
4 shall submit a report to the standard report recipients and the  
5 senate and house of representatives standing committees on  
6 appropriations on the amount of funds received and expended for the  
7 purposes authorized under this section.

8 Sec. 404. The department of civil rights shall submit  
9 quarterly reports to the standard report recipients that include  
10 all of the following information for the immediately preceding  
11 fiscal quarter:

12 (a) The number of all complaints received by the department by  
13 basis of complaint.

14 (b) The number of certified complaint cases initiated by basis  
15 of complaint.

16 (c) The number of certified complaint cases completed.

17 (d) The final disposition of certified complaint case  
18 investigations.

19 (e) The average number of days for a case to be completed  
20 after certification.

21 (f) The number of FTE positions filled from the FTE  
22 authorization for complaint investigations and enforcement.

23 (g) The number of open cases that have been open for more than  
24 1 year.

25 (h) The quotient of the number of certified cases completed  
26 divided by the number of filled FTE positions.

27 (i) A listing of amounts awarded to claimants.

28 Sec. 405. On submitting a report or complaint to the United  
29 States Commission on Civil Rights or any other federal department,

1 the department of civil rights shall submit a copy of the report or  
2 complaint to the standard report recipients not later than the next  
3 business day.

4 Sec. 406. From the funds appropriated in part 1, not later  
5 than January 31, the department of civil rights shall submit a  
6 report to the standard report recipients on the Native American  
7 boarding school study. The report must include all of the  
8 following:

9 (a) Information on the activities conducted for the study by  
10 the department of civil rights and any contracted university or  
11 entity.

12 (b) Total expenditures to date.

13 (c) The estimated date for publication of the final report.

14 Sec. 411. (1) From the funds appropriated in part 1 for  
15 museums support, \$500,000.00 must directly be awarded to support an  
16 Arab-American museum located in a county with a population over  
17 1,300,000 and in a city with a population of between 105,000 and  
18 115,000, according to the most recent federal decennial census.

19 (2) From the funds appropriated in part 1 for museums support,  
20 \$500,000.00 must directly be awarded to an African-American museum  
21 in a city with a population greater than 600,000, according to the  
22 most recent federal decennial census.

23 (3) From the funds appropriated in part 1 for museums support,  
24 \$500,000.00 must directly be awarded to support a memorial center  
25 in a county with a population of between 1,200,000 and 1,300,000  
26 and in a city with a population of between 83,000 and 84,000,  
27 according to the most recent federal decennial census.

28

29 **LEGISLATURE**

1           Sec. 600. The senate, the house of representatives, or an  
2 entity within the legislative branch may receive, expend, and  
3 transfer funds in addition to those authorized in part 1.

4           Sec. 601. (1) Funds appropriated in part 1 to an entity within  
5 the legislative branch must not be expended or transferred to  
6 another account without written approval of the authorized agent of  
7 the legislative entity. If the authorized agent of the legislative  
8 entity notifies the state budget director of its approval of an  
9 expenditure or transfer before the year-end book-closing date for  
10 that legislative entity, the state budget director shall  
11 immediately make the expenditure or transfer. The authorized  
12 legislative entity must be designated by the speaker of the house  
13 of representatives for house entities, the senate majority leader  
14 for senate entities, and the legislative council for legislative  
15 council entities.

16           (2) Funds appropriated within the legislative branch, to a  
17 legislative council component, must not be expended by any agency  
18 or other subgroup included in that component without the approval  
19 of the legislative council.

20           Sec. 602. The senate may charge rent and assess charges for  
21 utility costs. The amounts received for rent charges and utility  
22 assessments are appropriated to the senate for the renovation,  
23 operation, and maintenance of the Binsfeld Office Building.

24           Sec. 603. (1) From the appropriation contained in part 1 for  
25 national association dues, the first \$34,800.00 must be paid to the  
26 National Conference of Commissioners on Uniform State Laws. The  
27 remaining funds must be distributed by the legislative council in  
28 accordance with subsection (2).

29           (2) If any funds remain after all required dues have been paid

1 under subsection (1), the legislative council may approve the use  
2 of not more than \$10,000.00 to pay for the registration fees of any  
3 state employees who serve as board members to any of the national  
4 associations receiving state funds for annual dues to attend that  
5 national association's annual conference. If any of the \$10,000.00  
6 remains after national board member's registration fees are paid,  
7 the legislative council may use the remaining funds to pay for the  
8 registration fees for any other state employees to attend the  
9 annual conference of any of the national associations receiving  
10 state funds for annual dues.

11 Sec. 604. (1) The appropriation in part 1 to the Michigan  
12 state capitol historic site includes funds to operate the  
13 legislative parking facilities in the capitol area. The Michigan  
14 state capitol commission shall establish rules regarding the  
15 operation of the legislative parking facilities.

16 (2) The Michigan state capitol commission may collect a fee  
17 from state employees and the general public using certain  
18 legislative parking facilities. The revenues received from the  
19 parking fees are appropriated on receipt and must be allocated by  
20 the Michigan state capitol commission.

21 Sec. 605. The unexpended funds appropriated in part 1 for the  
22 legislative council are designated as a work project appropriation,  
23 and any unencumbered or unallotted funds shall not lapse at the end  
24 of the fiscal year and shall be available for expenditures for  
25 projects under this section until the projects have been completed.  
26 The following is in compliance with section 451a of the management  
27 and budget act, 1984 PA 431, MCL 18.1451a:

28 (a) The purpose of the project is publication of the Michigan  
29 manual.

1 (b) The project will be accomplished by utilizing state  
2 employees or contracts with service providers, or both.

3 (c) The total estimated cost of the project is \$3,000,000.00.

4 (d) The tentative completion date is September 30, 2029.

5 Sec. 606. The unexpended funds appropriated in part 1 for  
6 property management are designated as a work project appropriation,  
7 and any unencumbered or unallotted funds shall not lapse at the end  
8 of the fiscal year and shall be available for expenditures for  
9 projects under this section until the projects have been completed.  
10 The following is in compliance with section 451a of the management  
11 and budget act, 1984 PA 431, MCL 18.1451a:

12 (a) The purpose of the project is to purchase equipment and  
13 services for building maintenance to ensure a safe and productive  
14 work environment.

15 (b) The project will be accomplished by utilizing state  
16 employees or contracts with service providers, or both.

17 (c) The total estimated cost of the project is \$2,000,000.00.

18 (d) The tentative completion date is September 30, 2029.

19 Sec. 607. The unexpended funds appropriated in part 1 for  
20 automated data processing are designated as a work project  
21 appropriation, and any unencumbered or unallotted funds shall not  
22 lapse at the end of the fiscal year and shall be available for  
23 expenditures for projects under this section until the projects  
24 have been completed. The following is in compliance with section  
25 451a of the management and budget act, 1984 PA 431, MCL 18.1451a:

26 (a) The purpose of the project is to purchase equipment,  
27 software, and services to support and implement data processing  
28 requirements and technology improvements.

29 (b) The project will be accomplished by utilizing state

1 employees or contracts with service providers, or both.

2 (c) The total estimated cost of the project is \$3,000,000.00.

3 (d) The tentative completion date is September 30, 2029.

4 Sec. 608. In addition to funds appropriated in part 1, the  
5 Michigan capitol committee publications save the flags fund account  
6 may accept contributions, gifts, bequests, devises, grants, and  
7 donations. Those funds that are not expended in the fiscal year  
8 ending September 30, 2025 do not lapse at the close of the fiscal  
9 year, and must be carried forward for expenditure in the following  
10 fiscal years.

11 Sec. 611. (1) From the funds appropriated in part 1 for  
12 senate, \$250,000.00 must be allocated for an internship program.

13 (2) From the funds appropriated in part 1 for house of  
14 representatives, \$250,000.00 must be allocated for an internship  
15 program.

16 Sec. 612. It is the intent of the legislature that the  
17 appropriation in part 1 for the independent citizens redistricting  
18 commission complies with the legislature's obligation under section  
19 6(6) of article IV of the state constitution of 1963 and is to be  
20 used to fulfill the independent citizens redistricting commission's  
21 request to cover additional legal costs in a manner that is  
22 consistent with the current dormancy plan of the independent  
23 citizens redistricting commission. It is the intent of the  
24 legislature that this appropriation is contingent on the  
25 independent citizens redistricting commission submitting quarterly  
26 reports of expenditures to the governor and the legislature in  
27 accordance with section 6(5) of article IV of the state  
28 constitution of 1963. Each report must include a full accounting of  
29 the independent citizens redistricting commission's actual legal

1 costs incurred as part of defending any litigation regarding an

8 **LEGISLATIVE AUDITOR GENERAL**

9 Sec. 620. In accordance with section 53 of article IV of the  
10 state constitution of 1963, the auditor general shall conduct  
11 audits of the executive, judicial, and legislative branches.

12 Sec. 621. (1) The auditor general shall take all reasonable  
13 steps to ensure that certified minority- and women-owned and  
14 operated accounting firms, accounting firms owned and operated by  
15 persons with disabilities, and accounting firms that are  
16 geographically disadvantaged business enterprises participate in  
17 the audits of the books, accounts, and financial affairs of each  
18 principal executive department, branch, institution, agency, and  
19 office of this state.

20 (2) If the auditor general contracts with a firm to perform  
21 audits of the principal executive departments and state agencies,  
22 the auditor general shall strongly encourage the firm to  
23 subcontract with certified minority- and women-owned and operated  
24 accounting firms, accounting firms owned and operated by persons  
25 with disabilities, and accounting firms that are geographically  
26 disadvantaged business enterprises.

27 (3) Not later than November 1, the auditor general shall  
28 submit a report to the standard report recipients regarding the  
29 number of contracts entered into with certified minority- and

1 women-owned and operated accounting firms, accounting firms owned  
2 and operated by persons with disabilities, and accounting firms  
3 that are geographically disadvantaged business enterprises.

4 Sec. 622. From the funds appropriated in part 1 to the office  
5 of the auditor general, the auditor general's salary and the  
6 salaries of the remaining 2.0 FTE unclassified positions must be  
7 set by the speaker of the house of representatives, the senate  
8 majority leader, the house of representatives minority leader, and  
9 the senate minority leader.

10 Sec. 623. Any audits, reviews, or investigations requested of  
11 the auditor general by the legislature or by legislative  
12 leadership, legislative committees, or individual legislators must  
13 include an estimate of the additional costs involved and, if those  
14 costs exceed \$50,000.00, must provide supplemental funding. The  
15 auditor general shall determine whether to perform those activities  
16 in accordance with Operations Manual Policy No. 2-26.

17 Sec. 625. A branch, department, office, board, commission,  
18 agency, authority, or institution of this state shall not deny the  
19 auditor general access to examine its confidential information. The  
20 auditor general is subject to the same duty of confidentiality  
21 imposed by law on the entity providing the confidential  
22 information.

23 Sec. 627. The unexpended funds appropriated in part 1 for  
24 field operations are designated as a work project appropriation,  
25 and any unencumbered or unallotted funds shall not lapse at the end  
26 of the fiscal year and shall be available for expenditures for  
27 projects under this section until the projects have been completed.  
28 The following is in compliance with section 451a of the management  
29 and budget act, 1984 PA 431, MCL 18.1451a:



1 (a) The purpose of the project is to conduct the state of  
2 Michigan annual comprehensive financial report.

3 (b) The project will be accomplished by utilizing state  
4 employees and contract audits.

5 (c) The total estimated cost of the project is \$3,000,000.00.

6 (d) The tentative completion date is September 30, 2029.

7 Sec. 628. On a quarterly basis, the auditor general shall  
8 submit a report to the standard report recipients, the chairpersons  
9 of the senate and house of representatives appropriations  
10 committees, and the senate and house of representatives oversight  
11 committees that includes all of the following information related  
12 to projects initiated during the immediately preceding quarter:

13 (a) Audit title.

14 (b) Audit type.

15 (c) Audit period.

16 (d) Audit objectives.

17 (e) Branch of government being audited.

18 (f) Whether the auditor general or a contracted auditor is  
19 conducting the audit and, if a contracted auditor is conducting the  
20 audit, the identity of the contracted auditor.

21 (g) Details regarding the reason for initiating the audit,  
22 including whether it was discretionary or required by statute.

23 (h) To the extent authorized by law, details regarding any  
24 inquiry, tip, or request related to the audit that the auditor  
25 general received before initiating the audit.

26 (i) Details regarding any similar audit the auditor general  
27 has completed in the past.

28 (j) Estimated time frame for completion of the audit.

29 (k) Estimated total auditor general resources necessary to

1 complete the audit and release a report.

2 (l) Estimated total departmental or agency resources necessary  
3 to respond to the audit.

4 Sec. 629. On a quarterly basis, the auditor general shall  
5 submit a report to the standard report recipients, the chairpersons  
6 of the senate and house of representatives appropriations  
7 committees, and the senate and house of representatives oversight  
8 committees that includes all of the following information for each  
9 project in progress during the immediately preceding quarter:

10 (a) Audit title.

11 (b) Date the audit was initiated.

12 (c) Audit status.

13 (d) Estimated time frame for completion of the audit.

14 (e) Details regarding the resources spent on the audit to  
15 date.

16 (f) Estimated total auditor general resources necessary to  
17 complete the audit and release a report.

18 (g) Details regarding departmental or agency resources spent  
19 on the audit to date.

20 (h) Estimated total departmental or agency resources necessary  
21 to respond to the audit.

22 Sec. 630. On a quarterly basis, the auditor general shall  
23 submit a report to the standard report recipients, the chairpersons  
24 of the senate and house of representatives appropriations  
25 committees, and the senate and house of representatives oversight  
26 committees that contains all of the following information for each  
27 project completed during the immediately preceding quarter:

28 (a) Audit title.

29 (b) Date the audit was initiated.

1 (c) Date the audit report was released.

2 (d) Results of the audit, including the number and type of  
3 findings.

4 (e) Details regarding total auditor general resources spent on  
5 the audit.

6 (f) Details regarding total departmental or agency resources  
7 spent on the audit.

9 **DEPARTMENT OF STATE**

10 Sec. 701. (1) In addition to the funds appropriated in part 1,  
11 there is appropriated an amount not to exceed \$500,000.00 for  
12 federal contingency authorization. Amounts appropriated under this  
13 subsection are not available for expenditure until they have been  
14 transferred to another line item in part 1 under section 393(2) of  
15 the management and budget act, 1984 PA 431, MCL 18.1393.

16 (2) In addition to the funds appropriated in part 1, there is  
17 appropriated an amount not to exceed \$500,000.00 for state  
18 restricted contingency authorization. Amounts appropriated under  
19 this subsection are not available for expenditure until they have  
20 been transferred to another line item in part 1 under section  
21 393(2) of the management and budget act, 1984 PA 431, MCL 18.1393.

22 (3) In addition to the funds appropriated in part 1, there is  
23 appropriated an amount not to exceed \$25,000.00 for local  
24 contingency authorization. Amounts appropriated under this  
25 subsection are not available for expenditure until they have been  
26 transferred to another line item in part 1 under section 393(2) of  
27 the management and budget act, 1984 PA 431, MCL 18.1393.

28 (4) In addition to the funds appropriated in part 1, there is  
29 appropriated an amount not to exceed \$100,000.00 for private

1 contingency authorization. Amounts appropriated under this  
2 subsection are not available for expenditure until they have been  
3 transferred to another line item in part 1 under section 393(2) of  
4 the management and budget act, 1984 PA 431, MCL 18.1393.

5 Sec. 703. From the funds appropriated in part 1, the MDOS  
6 shall sell copies of records, including, but not limited to,  
7 records of motor vehicles, off-road vehicles, snowmobiles,  
8 watercraft, mobile homes, personal identification cardholders,  
9 drivers, and boat operators only as authorized in section 208b of  
10 the Michigan vehicle code, 1949 PA 300, MCL 257.208b, section 7 of  
11 1972 PA 222, MCL 28.297, and sections 80130, 80315, 81114, and  
12 82156 of the natural resources and environmental protection act,  
13 1994 PA 451, MCL 324.80130, 324.80315, 324.81114, and 324.82156.  
14 The revenue received from the sale of records must be credited to  
15 the transportation administration collection fund created in  
16 section 810b of the Michigan vehicle code, 1949 PA 300, MCL  
17 257.810b. Not later than 15 days after the close of each quarter,  
18 the MDOS shall submit a quarterly report to the standard report  
19 recipients. Each report must include the number of records sold and  
20 the revenues collected during the immediately preceding quarter.

21 Sec. 704. From the funds appropriated in part 1, the secretary  
22 of state may contract with the MDOC for the manufacture of vehicle  
23 registration plates 15 months before the registration year in which  
24 the registration plates will be used.

25 Sec. 705. (1) The MDOS may accept gifts, donations,  
26 contributions, and grants of money and other property from any  
27 private or public source to underwrite, in whole or in part, the  
28 cost of a departmental publication that is prepared and  
29 disseminated under the Michigan vehicle code, 1949 PA 300, MCL

1 257.1 to 257.923. A private or public funding source may receive  
2 written recognition in the publication and may furnish a traffic  
3 safety message, subject to approval of the MDOS, for inclusion in  
4 the publication. The MDOS may reject a gift, donation,  
5 contribution, or grant. The MDOS may furnish copies of a  
6 publication underwritten, in whole or in part, by a private source  
7 to the underwriter at no charge.

8 (2) The MDOS may sell and accept paid advertising for  
9 placement in a departmental publication that is prepared and  
10 disseminated under the Michigan vehicle code, 1949 PA 300, MCL  
11 257.1 to 257.923. The MDOS may charge and receive a fee for any  
12 advertisement appearing in a departmental publication and shall  
13 review and approve the content of each advertisement. The MDOS may  
14 refuse to accept advertising from any person or organization. The  
15 MDOS may furnish a reasonable number of copies of a publication to  
16 an advertiser at no charge.

17 (3) Pending expenditure, the funds received under this section  
18 must be deposited in the Michigan department of state publications  
19 fund created in section 211 of the Michigan vehicle code, 1949 PA  
20 300, MCL 257.211. Funds given, donated, or contributed to the MDOS  
21 from a private source are appropriated and allocated for the  
22 purpose for which the revenue is furnished. Funds granted to the  
23 MDOS from a public source are allocated and may be expended on  
24 receipt by the MDOS. The MDOS shall not accept a gift, donation,  
25 contribution, or grant if receipt is conditioned on a commitment of  
26 state funding at a future date. Revenue received from the sale of  
27 advertising is appropriated and may be expended on receipt by the  
28 MDOS.

29 (4) Any unexpended revenues received under this section must

1 be carried over into subsequent fiscal years and are available for  
2 appropriation for the purposes described in this section.

3 (5) Not later than March 1, the MDOS shall submit a report to  
4 the standard report recipients that includes all of the following  
5 information for the immediately preceding fiscal year:

6 (a) The amount of gifts, contributions, donations, and grants  
7 of money received by the MDOS under section 705 of article 5 of  
8 2023 PA 119.

9 (b) A list of the expenditures made from the amounts received  
10 by the MDOS as reported in subdivision (a).

11 (c) A list of any gift, donation, contribution, or grant of  
12 property other than funding received by the MDOS under section 705  
13 of article 5 of 2023 PA 119.

14 (d) The total revenue received from the sale of paid  
15 advertising accepted under this section and a statement of the  
16 total number of advertising transactions.

17 (6) In addition to copies delivered without charge as the  
18 secretary of state considers necessary, the MDOS may sell copies of  
19 manuals and other publications regarding the sale, ownership, or  
20 operation or regulation of motor vehicles, with amendments, at  
21 prices to be established by the secretary of state. As used in this  
22 subsection, the term "manuals and other publications" includes  
23 videos and proprietary electronic publications. All funds received  
24 from sales of these manuals and other publications must be credited  
25 to the Michigan department of state publications fund created in  
26 section 211 of the Michigan vehicle code, 1949 PA 300, MCL 257.211.

27 Sec. 707. Funds collected by the MDOS under section 211 of the  
28 Michigan vehicle code, 1949 PA 300, MCL 257.211, are appropriated  
29 for all expenses necessary to provide for the costs of the

1 publication described in section 211 of the Michigan vehicle code,  
2 1949 PA 300, MCL 257.211. Funds are allocated for expenditure when  
3 they are received by the department of treasury and do not lapse to  
4 the general fund at the end of the fiscal year.

5 Sec. 708. From the funds appropriated in part 1, the MDOS  
6 shall use available balances at the end of the state fiscal year to  
7 provide payment to the MDSP in the amount of \$332,000.00 for the  
8 services provided by the traffic accident records program as first  
9 appropriated in 1990 PA 196 and 1990 PA 208.

10 Sec. 709. From the funds appropriated in part 1, the MDOS may  
11 restrict funds from miscellaneous revenue to cover cash shortages  
12 created from normal branch office operations. The restricted amount  
13 must not exceed \$50,000.00 of the total funds available in  
14 miscellaneous revenue.

15 Sec. 711. Collector plate and fund-raising registration plate  
16 revenues collected by the MDOS are appropriated and allotted for  
17 distribution to the recipient university or public or private  
18 agency overseeing a state-sponsored goal when received.  
19 Distributions must occur on a quarterly basis or as otherwise  
20 authorized by law. Any revenues remaining at the end of the fiscal  
21 year do not lapse to the general fund and remain available for  
22 distribution to the university or agency in the next fiscal year.

23 Sec. 713. (1) The MDOS, in collaboration with the Gift of Life  
24 Michigan or its successor federally designated organ procurement  
25 organization, may develop and administer a public information  
26 campaign concerning the Michigan organ donor program.

27 (2) The MDOS may solicit funds from any private or public  
28 source to underwrite, in whole or in part, the public information  
29 campaign authorized by this section. The MDOS may accept gifts,

1 donations, contributions, and grants of money and other property  
2 from private and public sources for this purpose. A private or  
3 public funding source underwriting the public information campaign,  
4 in whole or in substantial part, shall receive sponsorship credit  
5 for its financial backing.

6 (3) Funds received under this section, including grants from  
7 state and federal agencies, do not lapse to the general fund at the  
8 end of the fiscal year and remain available for expenditure for the  
9 purposes described in this section.

10 (4) Funding appropriated in part 1 for the organ donor program  
11 must be used to produce a pamphlet regarding organ donations and to  
12 distribute the pamphlet with driver licenses and personal  
13 identification cards. The pamphlet must do both of the following:

14 (a) Explain the organ donor program and encourage people to  
15 become donors by marking a checkoff on driver license and personal  
16 identification card applications.

17 (b) Include a return reply form addressed to the gift of life  
18 organization.

19 (5) Funding appropriated in part 1 for the organ donor program  
20 must be used to pay for return postage costs of the return reply  
21 form described in subsection (4) (b).

22 (6) In addition to the appropriations in part 1, the MDOS may  
23 receive and expend funds from the organ and tissue donation  
24 education fund for administrative expenses.

25 (7) Not later than March 1, the department shall submit a  
26 report to the standard report recipients. The report must include  
27 all of the following:

28 (a) The amount of revenue collected by the MDOS under this  
29 section.



1 (b) The purpose of each expenditure.

2 (c) The amount of revenue carried forward.

3 Sec. 714. (1) Except as otherwise provided under subsection  
4 (2), not less than 180 days before closing a branch office or  
5 consolidating a branch office and not less than 60 days before  
6 relocating a branch office, the MDOS shall submit a report to the  
7 standard report recipients, the members of the senate and house of  
8 representatives standing committees on appropriations, and  
9 legislators who represent affected areas. The report must include  
10 all of the following:

11 (a) All analyses done regarding criteria for changes in the  
12 location of branch offices, including, but not limited to, all of  
13 the following:

14 (i) Branch transactions.

15 (ii) Revenue.

16 (iii) The impact on citizens of the affected area, including  
17 information regarding additional distance to branch office  
18 locations resulting from the changes.

19 (b) Detailed estimates of costs and savings that will result  
20 from the overall changes made to the branch office structure.

21 (c) Detailed estimates of costs for new leased facilities and  
22 expansions of current leased space.

23 (2) If the consolidation of a branch office is with another  
24 branch office that is located within the same local unit of  
25 government or the relocation of a branch office is to another  
26 location that is located within the same local unit of government,  
27 the MDOS is not required to submit a report under subsection (1).

28 (3) As used in this section, "local unit of government" means  
29 a city, village, township, or county.

1           Sec. 715. (1) Any service assessment collected by the MDOS  
2 from the user of a credit or debit card under section 3 of 1995 PA  
3 144, MCL 11.23, may be used by the MDOS for necessary expenses  
4 related to that service and may be remitted to a credit or debit  
5 card company, bank, or other financial institution.

6           (2) The service assessment imposed by the MDOS for credit and  
7 debit card services may be based on a percentage of each individual  
8 credit or debit card transaction or a flat rate per transaction, or  
9 both, scaled to the amount of the transaction. However, the  
10 department shall not charge any amount for a service assessment  
11 that exceeds the costs billable to the MDOS for the service  
12 assessment.

13           (3) If there is a balance of service assessments received from  
14 credit and debit card services remaining on September 30, the  
15 balance may be carried forward to the following fiscal year and  
16 appropriated for the same purpose.

17           (4) As used in this section, "service assessment" means costs  
18 associated with service fees imposed by credit and debit card  
19 companies and processing fees imposed by banks and other financial  
20 institutions.

21           Sec. 717. (1) The MDOS may accept gifts, donations, or  
22 contributions of property from any private or public source to  
23 support, in whole or in part, the operation of a departmental  
24 function relating to licensing, regulation, or safety. The MDOS may  
25 recognize a private or public contributor for making the  
26 contribution. The MDOS may reject a gift, donation, or  
27 contribution. Any revenues received under this subsection may be  
28 expended for the departmental functions relating to licensing,  
29 regulation, or safety.

1           (2) The MDOS shall not accept a gift, donation, or  
2 contribution under subsection (1) if receipt of the gift, donation,  
3 or contribution is conditioned on a commitment of future state  
4 funding.

5           (3) Not later than March 1, the MDOS shall submit a report to  
6 the standard report recipients. The report must include a list of  
7 each gift, donation, or contribution received by the department  
8 under subsection (1) for the immediately preceding calendar year.

9           Sec. 718. From the funds appropriated in part 1 for election  
10 regulation, all money must be spent in accordance with the Michigan  
11 election law, 1954 PA 116, MCL 168.1 to 168.992, and the  
12 instructions, orders, and guidance of the secretary of state  
13 regarding the proper method for the conduct and administration of  
14 elections.

15           Sec. 719. Not later than February 1, the MDOS shall submit a  
16 report to the standard report recipients on all funding allocated  
17 to counties, cities, and townships from the funds appropriated in  
18 part 1 for election administration and services. The report must  
19 include the amount and purpose of each payment provided to a  
20 county, city, or township.

21           Sec. 722. (1) From the funds appropriated in part 1, not later  
22 than February 1, the MDOS shall submit an expense report related to  
23 CARS to the standard report recipients and the senate and house of  
24 representatives standing committees on appropriations. The report  
25 must include itemized expenditures made on behalf of CARS by fund  
26 source in the immediately preceding fiscal year and projected  
27 expenditures to be made on behalf of CARS in the current fiscal  
28 year and the next fiscal year.

29           (2) As used in this section, "CARS" means the customer and

1 automotive records system.

2

3 **DEPARTMENT OF TECHNOLOGY, MANAGEMENT, AND BUDGET**

4 Sec. 801. (1) In addition to the funds appropriated in part 1,  
5 there is appropriated an amount not to exceed \$1,000,000,000.00 for  
6 federal contingency authorization. Amounts appropriated under this  
7 subsection are not available for expenditure until they have been  
8 transferred to another line item in part 1 under section 393(2) of  
9 the management and budget act, 1984 PA 431, MCL 18.1393.

10 (2) In addition to the funds appropriated in part 1, there is  
11 appropriated an amount not to exceed \$300,000,000.00 for state  
12 restricted contingency authorization. Amounts appropriated under  
13 this subsection are not available for expenditure until they have  
14 been transferred to another line item in part 1 under section  
15 393(2) of the management and budget act, 1984 PA 431, MCL 18.1393.

16 (3) In addition to the funds appropriated in part 1, there is  
17 appropriated an amount not to exceed \$20,000,000.00 for local  
18 contingency authorization. Amounts appropriated under this  
19 subsection are not available for expenditure until they have been  
20 transferred to another line item in part 1 under section 393(2) of  
21 the management and budget act, 1984 PA 431, MCL 18.1393.

22 (4) In addition to the funds appropriated in part 1, there is  
23 appropriated an amount not to exceed \$20,000,000.00 for private  
24 contingency authorization. Amounts appropriated under this  
25 subsection are not available for expenditure until they have been  
26 transferred to another line item in part 1 under section 393(2) of  
27 the management and budget act, 1984 PA 431, MCL 18.1393.

28 Sec. 802. Any proceeds that exceed necessary costs incurred in  
29 conducting transfers or auctions of state surplus property made

1 under section 267 of the management and budget act, 1984 PA 431,  
2 MCL 18.1267, are appropriated to the MDTMB to offset any costs  
3 incurred in the acquisition and distribution of surplus, salvage,  
4 or scrap property. The MDTMB shall provide consolidated internet  
5 auction services through this state's contractors for all local  
6 units of government.

7 Sec. 803. (1) The MDTMB may receive and expend funds in  
8 addition to those authorized by part 1 for maintenance and  
9 operation services provided specifically to other principal  
10 executive departments or state agencies, the legislative branch,  
11 the judicial branch, or private tenants, or provided in connection  
12 with facilities transferred to the operational jurisdiction of the  
13 MDTMB.

14 (2) The MDTMB may receive and expend funds in addition to  
15 those authorized by part 1 for real estate, architectural, design,  
16 engineering, and project oversight services provided specifically  
17 to other principal executive departments or state agencies, the  
18 legislative branch, the judicial branch, universities, community  
19 colleges, or private tenants.

20 (3) The MDTMB may receive and expend funds in addition to  
21 those authorized in part 1 for mail pickup and delivery services  
22 provided specifically to other principal executive departments and  
23 state agencies, the legislative branch, or the judicial branch.

24 (4) The MDTMB may receive and expend funds in addition to  
25 those authorized in part 1 for purchasing services provided  
26 specifically to other principal executive departments and state  
27 agencies, the legislative branch, or the judicial branch.

28 (5) Any revenue collected by the MDTMB from user fees under  
29 subsections (1) to (4) must be carried forward and does not lapse

1 to the general fund at the close of the fiscal year.

2 Sec. 805. To the extent a specific appropriation is required  
3 for a detailed source of financing included in part 1 for the MDTMB  
4 appropriations financed from special revenue and internal service  
5 and pension trust funds, or SIGMA user charges, the specific  
6 amounts are appropriated within the special revenue internal  
7 service and pension trust funds in portions not to exceed the  
8 aggregate amount appropriated in part 1.

9 Sec. 807. Funding in part 1 for SIGMA must be funded by  
10 proportionate charges assessed against the respective state funds  
11 benefiting from the SIGMA project in the amounts determined by  
12 MDTMB.

13 Sec. 808. (1) A deposit against the IDG from building  
14 occupancy and parking charges appropriated in part 1 must be  
15 collected, in part, from state agencies, the legislative branch,  
16 and the judicial branch based on estimated costs associated with  
17 maintenance and operation of buildings managed by MDTMB. To the  
18 extent excess revenue is collected due to estimates of building  
19 occupancy charges exceeding actual costs, the excess revenue may be  
20 carried forward into subsequent fiscal years for the purpose of  
21 returning funds to state agencies.

22 (2) An appropriation in part 1 for building occupancy and  
23 parking charges may be increased to return excess revenue collected  
24 to state agencies.

25 Sec. 809. On a biannual basis, the MDTMB shall submit a report  
26 to the standard report recipients on any revisions either  
27 individually or in the aggregate that increase or decrease current  
28 contracts by more than \$500,000.00 for computer software  
29 development, hardware acquisition, or quality assurance.

1           Sec. 810. (1) From the funds appropriated in part 1, the MDTMB  
2 shall maintain an internet website that contains notice of all  
3 solicitations, invitations for bids, and requests for proposals  
4 over \$50,000.00 that are issued by the MDTMB or by any state agency  
5 operating under delegated authority, except for solicitations up to  
6 \$500,000.00 in accordance with the MDTMB policy regarding providing  
7 opportunities to Michigan small businesses, geographically  
8 disadvantaged business enterprises, Michigan veteran-owned  
9 business, Michigan service disabled veteran-owned businesses, or  
10 Michigan recognized community rehabilitation organizations, or if  
11 the MDTMB determines and documents that it is in the best interest  
12 of this state. This information must appear on the first page of  
13 each department or state agency dashboard.

14           (2) The MDTMB shall set the due date for acceptance of an  
15 invitation for bid or request for proposal to not less than 14 days  
16 after the notice is made available on the internet website  
17 described in subsection (1), unless the MDTMB determines and  
18 documents that a different due date is in the best interest of this  
19 state.

20           (3) In addition to the requirements of this section, the MDTMB  
21 may advertise the solicitations, invitations for bids, and requests  
22 for proposals in any manner that the MDTMB determines is  
23 appropriate to give the greatest number of persons the opportunity  
24 to respond or make bids or requests for proposals.

25           (4) A new request for a proposal that is publicly displayed on  
26 the website must include the proposal's corresponding department or  
27 agency. The website must allow the searching of requests for  
28 proposals by department or agency.

29           Sec. 811. From the funds appropriated in part 1, the MDTMB

1 shall maintain a system that interfaces with other departments or  
2 agencies to keep track of the performance of vendors in fulfilling  
3 contract obligations. The performance of these vendors must be  
4 recorded and used as a factor to determine future contracts awarded  
5 in the procurement process.

6 Sec. 813. (1) Funds in part 1 for motor vehicle fleet are  
7 appropriated to the MDTMB for administration and the acquisition,  
8 lease, operation, maintenance, repair, replacement, and disposal of  
9 state motor vehicles.

10 (2) The funds described in subsection (1) must be funded by  
11 revenue from rates charged to principal executive departments and  
12 agencies for utilizing vehicle travel services provided by the  
13 MDTMB. Any revenue in excess of the amount appropriated in part 1  
14 from the motor transport fund and any unencumbered funds are  
15 restricted revenues and may be carried over into the succeeding  
16 fiscal year.

17 (3) The MDTMB shall, not later than 90 days after the close of  
18 the fiscal year, submit an annual report to the standard report  
19 recipients regarding the operation of the motor vehicle fleet. The  
20 report must include all of the following:

21 (a) The number of vehicles assigned to, or authorized for use  
22 by, state departments and agencies.

23 (b) The number of vehicles in the motor vehicle fleet.

24 (c) The number of miles driven by fleet vehicles.

25 (d) The number of gallons of fuel consumed by fleet vehicles.

26 (e) A description of fleet garage operations.

27 (f) The goods sold and services provided by the fleet garage.

28 (g) The number of employees assigned to each fleet garage.

29 (4) The information provided under subsection (3) may be



1 adjusted during the fiscal year based on needs and cost savings to  
2 achieve the maximum value and efficiency from the state motor  
3 fleet.

4 (5) The MDTMB shall adjust vehicle travel service rates  
5 charged to state departments and agencies if the cost of fuel  
6 changes by more than 10% of the budgeted price per gallon,  
7 regardless of whether the change is positive or negative. The MDTMB  
8 shall notify state departments and agencies, in writing or by  
9 email, not less than 30 days before implementing rate changes for  
10 fuel costs. Any revenue received from these charges is appropriated  
11 on receipt.

12 (6) The state budget director, on notification to the senate  
13 and house of representatives standing committees on appropriations,  
14 may adjust spending authorization and the IDG from motor transport  
15 fund in the MDTMB to ensure that the appropriations for motor  
16 vehicle fleet in the MDTMB budget equal the expenditures for motor  
17 vehicle fleet in the budgets for all executive branch agencies.

18 Sec. 820. The MDTMB shall post on its website and make  
19 available to the public a list of all parcels of real property  
20 owned by this state that are available for purchase.

21 Sec. 822. Not later than January 1, the MDTMB shall submit a  
22 report to the standard report recipients related to the salaries of  
23 unclassified employees and gubernatorial appointees within all  
24 state departments and agencies. The report must enumerate each  
25 unclassified employee and gubernatorial appointee and the  
26 employee's or appointee's annual salary rounded to the nearest  
27 thousand dollars.

28 Sec. 822c. The funds appropriated in part 1 must not be used  
29 to support any staff effort, projects, consultant expenses, or any

1 other activity related to the development, financing, construction,  
2 operation, or implementation of the Gordie Howe International  
3 Crossing or any successor project unless the approval of the  
4 project is enacted into law.

5 Sec. 822d. Not later than December 31, the MDTMB shall submit  
6 a report to the standard report recipients that includes all of the  
7 following:

8 (a) The fee and rate schedules to be used by state departments  
9 and agencies for services, including information technology,  
10 provided by the MDTMB during the current fiscal year.

11 (b) The changes from fees and rates charged in the immediately  
12 preceding fiscal year.

13 (c) An explanation of the factors that justify each fee and  
14 rate increase described in subdivision (b).

15 Sec. 822e. The MDTMB may receive and expend funds from the  
16 Vietnam veterans memorial monument fund in accordance with the  
17 Michigan Vietnam veterans memorial act, 1988 PA 234, MCL 35.1051 to  
18 35.1057. The funds are appropriated and allocated when received by  
19 the MDTMB and may be expended on receipt.

20 Sec. 822f. The Michigan veterans' memorial park commission may  
21 receive and expend money from any source, public or private,  
22 including, but not limited to, gifts, grants, donations of money,  
23 and government appropriations, for the purposes described in  
24 Executive Order No. 2001-10. The funds are appropriated and  
25 allocated when received by the Michigan veterans' memorial park  
26 commission and may be expended on receipt. Any deposit made under  
27 this section and any unencumbered funds are restricted revenues and  
28 may be carried over into subsequent fiscal years.

29 Sec. 822g. In addition to the funds appropriated in part 1,

1 the MDTMB may receive and expend money from the Michigan law  
2 enforcement officers memorial monument fund in accordance with the  
3 Michigan law enforcement officers memorial act, 2004 PA 177, MCL  
4 28.781 to 28.786. Any deposit made into the fund is restricted  
5 revenues and must be carried over into succeeding fiscal years.

6 Sec. 822h. Funds appropriated in part 1 for business support  
7 services may be used to continue a comprehensive supplier risk and  
8 information subscription used for the precontract risk assessment  
9 program established by funding provided in 2017 PA 107.

10 Sec. 822i. (1) From the funds in part 1 for capital city  
11 services, the MDTMB shall provide reimbursement to a city to  
12 provide support for local infrastructure and municipal services,  
13 including, but not limited to, maintenance or improvement of local  
14 roads, sidewalks, public utility infrastructure, emergency  
15 response, traffic management, or other public safety services that  
16 support the state capitol and adjacent state facilities.

17 (2) The MDTMB shall reimburse the city described in subsection  
18 (1) quarterly for eligible expenses if the city provides supporting  
19 documentation related to the eligible expenses to the MDTMB and the  
20 eligible expenses are approved for reimbursement.

21 (3) The city described in subsection (1) shall maintain and  
22 provide any supporting documentation that is requested for auditing  
23 purposes.

24 Sec. 822j. The funds appropriated in part 1 must not be used  
25 to consolidate the testing laboratories for the department of  
26 agriculture and rural development or the department of natural  
27 resources.

28 Sec. 822k. (1) The make it in Michigan competitiveness fund is  
29 created within the state treasury.

1           (2) There is appropriated an amount not to exceed  
2 \$325,000,000.00 for state restricted contingency funds. These funds  
3 are not available for expenditure until they have been transferred  
4 to another line item in this article.

5           (3) Funds may be spent from the make it in Michigan  
6 competitiveness fund only on appropriation, or administrative  
7 transfer pursuant to subsection (4).

8           (4) A transfer of funds from federal or state restricted  
9 contingency funds into the make it in Michigan competitiveness fund  
10 may be made by the state budget director not less than 30 days  
11 after notifying each member of the senate and house of  
12 representatives appropriations committees. Those transfers may be  
13 disapproved by either appropriations committee within the 30 days  
14 and, if disapproved within that time, are not effective.

15           (5) A transfer approved under this section constitutes  
16 authorization to transfer the amount recommended and approved.  
17 However, the amount must be reduced by the state budget director to  
18 be within the current unobligated amount of the appropriation.

19           (6) Transfers must not be authorized under any of the  
20 following circumstances:

21           (a) To create a new line-item appropriation or to create a new  
22 state program.

23           (b) To or from an operating appropriation line item that did  
24 not appear in the fiscal year appropriation bills for which the  
25 transfer is being made.

26           (c) To or from a work project as designated under section 451a  
27 of the management and budget act, 1984 PA 431, MCL 18.1451a.

28           (d) Between state governmental funds.

29           (7) Interest and earnings from the investment of funds

1 deposited in the make it in Michigan competitiveness fund must be  
2 deposited in the general fund.

3 (8) Funds in the make it in Michigan competitiveness fund at  
4 the close of a fiscal year remain in the make it in Michigan  
5 competitiveness fund and do not lapse to the general fund.

6 (9) Funds appropriated or transferred from the make it in  
7 Michigan competitiveness fund are available to leverage federal  
8 funding opportunities that include, but are not limited to,  
9 infrastructure, health, public safety, mobility and  
10 electrification, climate and the environment, economic development,  
11 or other funding opportunities administered by the federal  
12 government. Funding opportunities may be in the form of formula or  
13 competitive-based grants, cooperative agreements, or contracts, and  
14 may include funds contained in the infrastructure investment and  
15 jobs act, Public Law 117-58, the CHIPS act of 2022, division A of  
16 Public Law 117-167, the inflation reduction act of 2022, Public Law  
17 117-169, or any other federal acts.

18 (10) The Michigan infrastructure office, in collaboration with  
19 the state budget director, shall form an interagency evaluation  
20 committee that includes the department of environment, Great Lakes,  
21 and energy, the MDLEO, the MDOT, the MSF, or other entities at the  
22 discretion of the Michigan infrastructure office, to develop  
23 program guidelines and selection criteria for the recommended  
24 appropriation or transfer of funds. The interagency evaluation  
25 committee shall make recommendations to the director of the MDTMB  
26 and the state budget director on the disbursement of funds. Funding  
27 must also be used to cover all costs related to the administration  
28 of this section.

29 (11) The MDTMB shall inform the legislature not later than 30

1 days after any federal funds are received that would be used as the  
2 basis for recommended appropriations or transfers from the make it  
3 in Michigan competitiveness fund.

4 (12) Not later than 90 days after the close of each fiscal  
5 year, the MDTMB shall report to the legislature on the projects  
6 funded with make it in Michigan competitiveness fund money.

7 Sec. 822l. (1) The office of retirement services shall contract  
8 with the state's actuary to conduct a study that provides an array  
9 of options and corresponding costs related to providing an increase  
10 in the cost-of-living adjustment in the state employees' retirement  
11 system created under section 2 of the state employees' retirement  
12 act, 1943 PA 240, MCL 38.2, which is currently the lesser of  
13 \$300.00 or 3% of a retiree's pension.

14 (2) The study must include all of the following:

15 (a) Options for 1-time and permanent adjustments.

16 (b) The number of individuals impacted.

17 (c) The short- and long-run costs of providing cost-of-living  
18 adjustments.

19 (3) The cost of the study must be paid for from unexpended and  
20 unencumbered funds appropriated in 2023 PA 119 for actuarial study.

21

22 Sec. 822m. It is the intent of the legislature that the state  
23 budget director use the state budget director's authority under  
24 section 451a of the management and budget act, 1984 PA 431, MCL  
25 18.1451a, to lapse any remaining work project authorization and  
26 seek any and all claw-back provisions relating to the following  
27 appropriations for the fiscal year ending September 20, 2023:

28 (a) Economic development and workforce grants, as that  
29 appropriation is described in section 1094m(1) (a) of article 5 of

1 2022 PA 166.

2 (b) Community health campus pilot project, as that  
3 appropriation is described in section 1996 of article 6 of 2022 PA  
4 166.

6 **INFORMATION TECHNOLOGY**

7 Sec. 824. The MDTMB may enter into agreements to provide  
8 spatial information and technical services to other principal  
9 executive departments, state agencies, local units of government,  
10 and other organizations. The MDTMB may receive and expend funds in  
11 addition to those authorized in part 1 for providing information  
12 and technical services, publications, maps, and other products. The  
13 MDTMB may expend amounts received for salaries, supplies, and  
14 equipment necessary to provide informational products and technical  
15 services.

16 Sec. 825. (1) The legislature shall have access to all  
17 historical and current data contained within SIGMA, or its  
18 predecessor, pertaining to state departments.

19 (2) State departments shall have access to all historical and  
20 current data contained within SIGMA or its predecessor.

21 Sec. 827. (1) Funds appropriated in part 1 for the Michigan  
22 public safety communications system may be expended only on  
23 approval of an expenditure plan by the state budget director.

24 (2) The MDTMB shall assess all subscribers of the Michigan  
25 public safety communications system reasonable access and  
26 maintenance fees and deposit the fees in the Michigan public safety  
27 communications systems fees fund.

28 (3) All money received by the MDTMB under this section must be  
29 expended for the support and maintenance of the Michigan public

1 safety communications system.

2 (4) Any deposits made under this section and unencumbered  
3 funds are restricted revenues and must be carried forward into  
4 succeeding fiscal years.

5 Sec. 828. Not later than 45 days after the end of the current  
6 fiscal year, the MDTMB shall submit a report to the standard report  
7 recipients that includes both of the following:

8 (a) The estimated total amount of funding appropriated for  
9 information technology services and projects, by funding source,  
10 for all principal executive departments and agencies for the  
11 immediately preceding fiscal year.

12 (b) A listing of the expenditures made from the amounts  
13 received by the MDTMB as reported in subdivision (a).

14 Sec. 831. If the MDTMB provides information technology  
15 services to a department or agency directly, the MDTMB shall submit  
16 a monthly invoice to the department or agency for the information  
17 technology services provided. If the MDTMB provides information  
18 technology services to a department or agency through a contracted  
19 vendor, the MDTMB shall submit an invoice to the department or  
20 agency not later than 60 days after the MDTMB receives approval to  
21 pay the vendor invoice.

22 Sec. 832. (1) The MDTMB shall inform the senate and house of  
23 representatives appropriations subcommittees on general government  
24 and the senate and house fiscal agencies not later than 30 days  
25 after learning of the proposal of a potential penalty proposed or  
26 the assessment of an actual penalty assessed by the federal  
27 government for failure of the Michigan child support enforcement  
28 system to achieve certification by the federal government.

29 (2) If a potential penalty is proposed by the federal



1 government, the MDTMB shall submit a report to the standard report  
2 recipients not later than 90 days after the date the potential  
3 penalty is proposed specifying the MDTMB's plans to avoid the  
4 assessment of an actual penalty and ensure federal certification of  
5 the Michigan child support enforcement system.

6 Sec. 833. (1) The state budget director, on notification to  
7 the standard report recipients and the senate and house of  
8 representatives standing committees on appropriations, may adjust  
9 spending authorization and user fees in the MDTMB to ensure that  
10 the appropriations for information technology in the MDTMB equal  
11 the appropriations for information technology in the budgets for  
12 all executive branch agencies.

13 (2) If, during the fiscal year, a supplemental appropriation  
14 or transfer is made under section 393(2) of the management and  
15 budget act, 1984 PA 431, MCL 18.1393, to or from an information  
16 technology line item in an agency budget, there is appropriated an  
17 equal amount of user fees in the MDTMB to accommodate an increase  
18 or decrease in spending authorization.

19 Sec. 834. (1) Any revenue collected from licenses issued under  
20 the antenna site management project shall be deposited in the  
21 antenna site management revolving fund created for this purpose in  
22 the MDTMB. The MDTMB may receive and expend money from the fund for  
23 costs associated with the antenna site management project,  
24 including the cost of a third-party site manager. Any excess  
25 revenue remaining in the fund at the close of the fiscal year must  
26 be proportionately transferred to the appropriate state restricted  
27 funds as designated in a PA or the state constitution of 1963.

28 (2) An antenna must not be placed on any site under this  
29 section without complying with the respective local zoning codes

1 and local unit of government processes.

2       Sec. 835. (1) In addition to the funds appropriated in part 1,  
3 the funds collected by the MDTMB for supplying census-related  
4 information and technical services, publications, statistical  
5 studies, population projections and estimates, and other  
6 demographic products are appropriated for all expenses necessary to  
7 provide the required services. These funds are available for  
8 expenditure when they are received and may be carried forward into  
9 the next fiscal year.

10       (2) Not later than March 1, the MDTMB shall submit a report to  
11 the standard report recipients that provides the amount of revenue  
12 collected by the MDTMB from the authorization in subsection (1) and  
13 the amount of revenue carried forward.

14       Sec. 837. All information technology projects funded by  
15 appropriations in part 1 must do both of the following:

16       (a) Use information technology project management best  
17 practices and services as defined or recommended by the enterprise  
18 portfolio management office of the MDTMB.

19       (b) Comply with the requirements of the state unified  
20 information technology environment methodology as it applies to all  
21 information technology project management processes.

22       Sec. 838. (1) The funds appropriated in part 1 for information  
23 technology investment fund must be used for the modernization of  
24 state information technology systems, improvement of this state's  
25 cybersecurity framework, and to achieve efficiencies.

26       (2) The MDTMB shall develop a plan regarding the use of the  
27 funds appropriated in part 1 for the information technology  
28 investment fund.

29       (3) The plan described in subsection (2) must include all of

1 the following:

2 (a) A description of proposed information technology  
3 investment projects.

4 (b) The time frame for completion of the information  
5 technology investment projects.

6 (c) The initial budgeted amount for each project.

7 (d) The total initial budgeted amount for all projects.

8 (e) The number of employees assigned to implement each  
9 information technology investment project.

10 (f) The contracts entered into for each information technology  
11 investment project.

12 (g) Any other information the MDTMB considers necessary.

13 (4) The MDTMB shall submit a report to the standard report  
14 recipients that includes the plan and the anticipated spending  
15 reductions or overages for each of the proposed information  
16 technology investment projects. The report must also include both  
17 of the following:

18 (a) A comparison of the initial budgeted amounts and  
19 cumulative costs, both by project and in total for all projects,  
20 for each fiscal year plan.

21 (b) The amount of any transfer of budgeted funds from 1  
22 project to another.

23

24 **STATE BUILDING AUTHORITY RENT**

25 Sec. 842. (1) Funds appropriated in part 1 for state building  
26 authority rent may, in addition to this purpose, be expended for  
27 the payment of required premiums for insurance on facilities owned  
28 by the state building authority or payment of costs that may be  
29 incurred as the result of any deductible provisions in the

1 applicable insurance policies.

2 (2) If the amount appropriated in part 1 for state building  
3 authority rent is not sufficient to pay the rent obligations and  
4 insurance premiums and deductibles identified in subsection (1) for  
5 state building authority projects, there is appropriated from the  
6 general fund of this state the amount necessary to pay the  
7 obligations.

8 Sec. 843. (1) The funds appropriated in part 1 for statewide  
9 appropriations must be funded by assessments against longevity and  
10 insurance appropriations throughout state government in a manner  
11 prescribed by the MDTMB. The funds must be used as specified in  
12 joint labor/management agreements, or through the coordinated  
13 compensation hearings process. Any deposits of assessments made  
14 under this subsection and any unencumbered funds are restricted  
15 revenues, may be carried over into the succeeding fiscal years, and  
16 are appropriated.

17 (2) In addition to the funds appropriated in part 1 for  
18 statewide appropriations, the MDTMB may receive and expend funds in  
19 the additional amounts specified in joint labor/management  
20 agreements, or through the coordinated compensation hearings  
21 process, in the same manner and subject to the same conditions as  
22 prescribed in subsection (1).

23 Sec. 844. In addition to the funds appropriated in part 1, the  
24 MDTMB may receive and expend funds from other principal executive  
25 departments and state agencies to implement administrative leave  
26 bank transfer provisions specified in joint labor/management  
27 agreements. The funds may also be transferred to other principal  
28 executive departments and state agencies under the joint  
29 labor/management agreement and any amounts transferred under the

1 joint labor/management agreement are authorized for receipt and  
2 expenditure by the receiving principal executive department or  
3 state agency. Any funds received by the MDTMB under this section  
4 and intended, under the joint labor/management agreements, to be  
5 available for use beyond the close of the fiscal year, and any  
6 unencumbered funds, may be carried over into the next fiscal year.

7

8 **CIVIL SERVICE COMMISSION**

9       Sec. 850. (1) In accordance with section 5 of article XI of  
10 the state constitution of 1963, all restricted funds must be  
11 assessed a sum not less than 1% of the total aggregate payroll paid  
12 from those funds for financing the civil service commission on the  
13 basis of actual 1% restricted sources total aggregate payroll of  
14 the classified service for the preceding fiscal year. This  
15 includes, but is not limited to, restricted funds appropriated in  
16 part 1 of any appropriations act. The civil service commission  
17 shall return any unexpended funds appropriated under this  
18 subsection to each 1% fund source not later than 6 months after the  
19 end of the fiscal year.

20       (2) The appropriations in part 1 are estimates of actual  
21 charges based on payroll appropriations. With the approval of the  
22 state budget director, the civil service commission may adjust  
23 financing sources for civil service charges based on actual payroll  
24 expenditures, if the adjustments do not increase the total  
25 appropriation for the civil service commission.

26       (3) The financing from restricted sources must be credited to  
27 the civil service commission by the end of the second fiscal  
28 quarter.

29       Sec. 851. Except where specifically appropriated for this

1 purpose, financing from restricted sources must be credited to the  
2 civil service commission. For restricted sources of funding within  
3 the general fund that have the legislative authority for carryover,  
4 if current spending authorization or revenues are insufficient to  
5 accept the charge, the shortage must be taken from carryforward  
6 balances of that funding source. Restricted revenue sources that do  
7 not have carryforward authority must be utilized to satisfy civil  
8 service commission operating deductions first and civil service  
9 commission obligations second. General fund dollars are  
10 appropriated for any shortfall, if approved by the state budget  
11 director.

12 Sec. 852. The appropriation in part 1 to the civil service  
13 commission, for state-sponsored group insurance, flexible spending  
14 accounts, and COBRA, represents amounts, in part, included within  
15 the various appropriations throughout state government for the  
16 current fiscal year to fund the flexible spending account program  
17 included within the civil service commission. Deposits against  
18 state-sponsored group insurance, flexible spending accounts, and  
19 COBRA for the flexible spending account program must be made from  
20 assessments levied during the fiscal year in a manner prescribed by  
21 the civil service commission. Unspent employee contributions to the  
22 flexible spending accounts may be used to offset administrative  
23 costs for the flexible spending account program, and any remaining  
24 balance of unspent employee contributions lapses to the general  
25 fund.

26

27 **CAPITAL OUTLAY**

28 Sec. 860. As used in sections 861 through 875 of this part:

29 (a) "Board" means the state administrative board created in

1 section 1 of 1921 PA 2, MCL 17.1.

2 (b) "Community college" means a community college organized  
3 under the community college act of 1966, 1966 PA 331, MCL 389.1 to  
4 389.195, or under part 25 of the revised school code, 1976 PA 451,  
5 MCL 380.1601 to 380.1607, and does not include a state agency or  
6 university.

7 (c) "Director" means the director of the MDTMB.

8 (d) "State agency" means an agency of state government. State  
9 agency does not include a community college or university.

10 (e) "State building authority" means the authority created in  
11 section 2 of 1964 PA 183, MCL 830.412.

12 (f) "University" means a 4-year university supported by this  
13 state. University does not include a community college or a state  
14 agency.

15 Sec. 861. Each capital outlay project authorized in this part  
16 and part 1 or any previous capital outlay act shall comply with the  
17 procedures required by the management and budget act, 1984 PA 431,  
18 MCL 18.1101 to 18.1594.

19 Sec. 862. (1) The MDTMB shall submit a report to the standard  
20 report recipients and the JCOS on the status of each planning or  
21 construction project financed by the state building authority, this  
22 part and part 1, or a previous PA.

23 (2) Before the end of the fiscal year, the MDTMB shall submit  
24 a report to the standard report recipients and the JCOS for each  
25 capital outlay project other than lump sums that includes all of  
26 the following:

27 (a) The account number and name of each construction project.

28 (b) The balance remaining in each account.

29 (c) The date of the last expenditure from the account.

1 (d) The anticipated date of occupancy if the project is under  
2 construction.

3 (e) The appropriations history for the project.

4 (f) The professional service contractor.

5 (g) The amount of the project financed with federal funds.

6 (h) The amount of the project financed through the state  
7 building authority.

8 (i) The total authorized cost for the project and the state  
9 authorized share if different than the total.

10 (3) Before the end of the fiscal year, the MDTMB shall submit  
11 a report to the standard report recipients and the JCOS on all of  
12 the following for each project by a state agency, university, or  
13 community college that is authorized for planning but is not yet  
14 authorized for construction:

15 (a) The name of the project and account number.

16 (b) Whether a program statement is approved.

17 (c) Whether schematics are approved by the MDTMB.

18 (d) Whether preliminary plans are approved by the MDTMB.

19 (e) The name of the professional service contractor.

20 (4) As used in this section, "project" includes appropriation  
21 line items made for purchase of real estate.

22 Sec. 864. The appropriations in part 1 for capital outlay must  
23 be carried forward at the end of the fiscal year in accordance with  
24 section 248 of the management and budget act, 1984 PA 431, MCL  
25 18.1248.

26 Sec. 865. (1) A site preparation economic development fund is  
27 created in the MDTMB. The MEDC board and the state budget director  
28 shall determine whether a specific state-owned site qualifies for  
29 inclusion in the site preparation economic development fund.



1           (2) Any proceeds from the sale of an economic development site  
2 must be deposited in the site preparation economic development fund  
3 and are available for site preparation expenditures, unless  
4 otherwise provided by law. The economic development sites are  
5 authorized for sale consistent with state law. Expenditures from  
6 the site preparation economic development fund are authorized for  
7 site preparation activities that enhance the marketable sale value  
8 of the economic development sites.

9           (3) A cash advance in an amount of not more than  
10 \$25,000,000.00 is authorized from the general fund to the site  
11 preparation economic development fund.

12           (4) Not later than December 31, the MDTMB shall submit a  
13 report to the standard report recipients and the senate and house  
14 of representatives standing committees on appropriations that  
15 includes both of the following:

16           (a) The revenue and expenditure activity in the site  
17 preparation economic development fund for the immediately preceding  
18 fiscal year.

19           (b) The sites identified as economic development sites.

20           (5) As used in this section:

21           (a) "Economic development site" means a state-owned site that  
22 is declared as surplus property under section 251 of the management  
23 and budget act, 1984 PA 431, MCL 18.1251, and would provide  
24 economic benefit to the area of the site or to this state.

25           (b) "Site preparation activities" includes, but is not limited  
26 to, demolition, environmental studies and abatement, utility  
27 enhancement, and site excavation.

28           Sec. 866. (1) The energy efficiency revolving fund is created  
29 within the state treasury. The state treasurer may receive money or

1 other assets from any source for deposit into the energy efficiency  
2 revolving fund. The state treasurer shall direct the investment of  
3 the energy efficiency revolving fund. The state treasurer shall  
4 credit to the energy efficiency revolving fund interest and  
5 earnings from energy efficiency revolving fund investments.

6 (2) Money in the energy efficiency revolving fund at the close  
7 of the fiscal year remains in the energy efficiency revolving fund  
8 and does not lapse to the general fund.

9 (3) The MDTMB shall provide oversight and direction for the  
10 energy efficiency revolving fund, coordinate a call for projects,  
11 and prioritize the award of projects that will contribute to a  
12 reduction in this state's carbon footprint. State administrative  
13 costs must be not more than 10% of the total project cost.

14 (4) The MDTMB shall set terms with agencies participating in  
15 the energy efficiency revolving fund program that include the scope  
16 of each project, funding commitments, data collection and reporting  
17 requirements, and any other financial terms related to realization  
18 of energy savings related to implementation of the project. The  
19 MDTMB may enter into a memorandum of understanding to memorialize  
20 these terms.

21 (5) Not later than February 1, the MDTMB shall submit a report  
22 to the standard report recipients on projects funded under this  
23 section. The report must list each approved project, the amount  
24 provided from the energy efficiency revolving fund for each  
25 project, the department or agency under which the project belongs,  
26 anticipated annual savings from each project, and revenue from  
27 savings deposited into the energy efficiency revolving fund by  
28 project.

29

1 **CAPITAL OUTLAY - UNIVERSITIES AND COMMUNITY COLLEGES**

2           Sec. 873. (1) This section applies only to projects for  
3 community colleges.

4           (2) State support is directed towards the remodeling and  
5 additions, special maintenance, or construction of certain  
6 community college buildings. The community college shall obtain or  
7 provide for site acquisition and initial main utility installation  
8 to operate the facility. The funding must be composed of local and  
9 state shares and not more than 50% of a capital outlay project, not  
10 including a lump-sum special maintenance project or remodeling and  
11 addition project, for a community college may be appropriated from  
12 state and federal funds, unless otherwise appropriated by the  
13 legislature.

14           (3) An expenditure under this part and part 1 is authorized  
15 when the release of the appropriation is approved by the board on  
16 the recommendation of the director. The director may recommend to  
17 the board the release of any appropriation in part 1 only after the  
18 director is assured that the legal entity operating the community  
19 college to which the appropriation is made has complied with this  
20 part and part 1 and has matched the amounts appropriated as  
21 required by this part and part 1. A release of funds in part 1 must  
22 not exceed 50% of the total cost of planning and construction of  
23 any project, not including lump-sum remodeling and additions and  
24 special maintenance, unless otherwise appropriated by the  
25 legislature. Further planning and construction of a project  
26 authorized by this part and part 1 or applicable sections of the  
27 management and budget act, 1984 PA 431, MCL 18.1101 to 18.1594,  
28 must be in accordance with the purpose and scope as defined and  
29 delineated in the approved program statements and planning

1 documents. This part and part 1 are applicable to all projects for  
2 which planning appropriations were made in previous PAs.

3 (4) The community college shall take the steps necessary to  
4 secure available federal construction and equipment money for  
5 projects funded for construction in this part and part 1 if an  
6 application was not previously made. If there is a reasonable  
7 expectation that a previous year unfunded application may receive  
8 federal money in a subsequent year, the community college shall  
9 take whatever action necessary to keep the application active.

10 Sec. 874. If university and community college matching  
11 revenues are received in an amount less than the appropriations for  
12 capital projects contained in this part and part 1, the state funds  
13 must be reduced in proportion to the amount of matching revenue  
14 received.

15 Sec. 875. (1) The director may require that community colleges  
16 and universities that have an authorized project described in part  
17 1 submit documentation regarding the project match and governing  
18 board approval of the authorized project not more than 60 days  
19 after the beginning of the fiscal year.

20 (2) If the documentation required by the director under  
21 subsection (1) is not submitted, or does not adequately  
22 authenticate the availability of the project match or governing  
23 board approval of the authorized project, the director may  
24 terminate the authorization. The authorization terminates 30 days  
25 after the director notifies the JCOS of the intent to terminate the  
26 project unless the JCOS approves an extension of the authorization.

27

28 **ONE-TIME APPROPRIATIONS**

29 Sec. 890. From the unexpended and unencumbered funds

1 appropriated in 2022 PA 166 for information technology investment  
2 fund, the following appropriations shall be made:

3 (a) \$2,360,000.00 for enterprise language accessibility.

4 (b) \$1,365,000.00 for free feminine hygiene products pilot  
5 program.

6 (c) \$1,000.00 for building occupancy health and safety.

7 Sec. 891. From the funds appropriated under section 890(b),  
8 the MDTMB shall provide free menstrual discharge absorption devices  
9 in the restrooms of buildings owned or leased by this state.

10

11 **DEPARTMENT OF TREASURY**

12 **OPERATIONS**

13 Sec. 901. (1) In addition to the funds appropriated in part 1,  
14 there is appropriated an amount not to exceed \$1,000,000.00 for  
15 federal contingency authorization. Amounts appropriated under this  
16 subsection are not available for expenditure until they have been  
17 transferred to another line item in part 1 under section 393(2) of  
18 the management and budget act, 1984 PA 431, MCL 18.1393.

19 (2) In addition to the funds appropriated in part 1, there is  
20 appropriated an amount not to exceed \$10,000,000.00 for state  
21 restricted contingency authorization. Amounts appropriated under  
22 this subsection are not available for expenditure until they have  
23 been transferred to another line item in part 1 under section  
24 393(2) of the management and budget act, 1984 PA 431, MCL 18.1393.

25 (3) In addition to the funds appropriated in part 1, there is  
26 appropriated an amount not to exceed \$200,000.00 for local  
27 contingency authorization. Amounts appropriated under this  
28 subsection are not available for expenditure until they have been  
29 transferred to another line item in part 1 under section 393(2) of

1 the management and budget act, 1984 PA 431, MCL 18.1393.

2 (4) In addition to the funds appropriated in part 1, there is  
3 appropriated an amount not to exceed \$40,000.00 for private  
4 contingency authorization. Amounts appropriated under this  
5 subsection are not available for expenditure until they have been  
6 transferred to another line item in part 1 under section 393(2) of  
7 the management and budget act, 1984 PA 431, MCL 18.1393.

8 Sec. 902. (1) Amounts needed to pay for interest, fees,  
9 principal, mandatory and optional redemptions, arbitrage rebates as  
10 required by federal law, and costs associated with the payment,  
11 registration, trustee services, credit enhancements, and issuing  
12 costs in excess of the amount appropriated to the department of  
13 treasury in part 1 for debt service on notes and bonds that are  
14 issued by this state under sections 14, 15, or 16 of article IX of  
15 the state constitution of 1963, as implemented by 1967 PA 266, MCL  
16 17.451 to 17.455, are appropriated.

17 (2) In addition to the amount appropriated to the department  
18 of treasury for debt service in part 1, there is appropriated an  
19 amount for fiscal year cash-flow borrowing costs to pay for  
20 interest on interfund borrowing authorized under 1967 PA 55, MCL  
21 12.51 to 12.53.

22 (3) In addition to the amount appropriated to the department  
23 of treasury for debt service in part 1, all repayments received by  
24 this state on loans made from the school bond loan fund that the  
25 state treasurer determines are not required to be deposited in the  
26 school loan revolving fund under section 4 of 1961 PA 112, MCL  
27 388.984, are appropriated to the department of treasury for the  
28 payment of debt service, including, but not limited to, optional  
29 and mandatory redemptions, on bonds, notes, or commercial paper

1 issued by this state under 1961 PA 112, MCL 388.981 to 388.985.

2 Sec. 902a. As a condition of receiving the appropriations in  
3 part 1, not later than 30 days after a refunding or restructuring  
4 bond issue is sold, the department of treasury must submit a report  
5 to the standard report recipients and the senate and house of  
6 representatives standing committees on appropriations. The report  
7 must include all of the following:

8 (a) A comparison of the annual debt service before the  
9 refinancing or restructuring to the annual debt service after the  
10 refinancing or restructuring.

11 (b) The change in the principal and interest over the duration  
12 of the debt.

13 (c) The projected change in the present value of the debt  
14 service as a result of the refinancing and restructuring.

15 Sec. 902b. As a condition of receiving the appropriations in  
16 part 1, not later than 30 days after the state of Michigan  
17 comprehensive annual financial report under section 494 of the  
18 management and budget act, 1984 PA 431, MCL 18.1494, is published,  
19 the department of treasury shall submit a report to the standard  
20 report recipients on all funds that are controlled or administered  
21 by the department of treasury and not appropriated in part 1. The  
22 current and all previous reports prepared as required under this  
23 section must be saved and made available on the department of  
24 treasury's public website and stored in a common location with all  
25 other reports that the department of treasury is required by law to  
26 prepare. The link to the location of the reports must be clearly  
27 indicated on the main page of the department of treasury's internet  
28 website. The report must include all of the following information  
29 for each fund for the immediately preceding fiscal year:

- 1 (a) The starting balance.
- 2 (b) Total revenue generated by transfers in and investments.
- 3 (c) Total expenditures.
- 4 (d) The ending balance.

5 Sec. 903. (1) From the funds appropriated in part 1, the  
6 department of treasury may contract with law firms or private  
7 collection agencies to collect taxes and other accounts due this  
8 state or due a city for which the department of treasury has  
9 entered into an agreement to provide tax administration services.  
10 In addition to the amounts appropriated in part 1 to the department  
11 of treasury, there are appropriated amounts necessary to fund the  
12 cost of these collections, including infrastructure costs. The  
13 additional amounts appropriated under this subsection must not  
14 exceed 25% of the collections or 2.5% plus operating costs, as  
15 applicable. Each contract must prescribe the applicable amount. The  
16 amounts appropriated to fund collection costs and fees under this  
17 subsection are appropriated from the fund or account to which the  
18 corresponding taxes and other accounts being collected are recorded  
19 or dedicated. However, if the taxes and other accounts collected  
20 are dedicated for a specific purpose under the state constitution

23 (2) From the funds appropriated in part 1, the department of  
24 treasury may contract with law firms or private collections  
25 agencies to collect defaulted student loans and other accounts due  
26 the Michigan guaranty agency. In addition to the amounts  
27 appropriated in part 1 to the department of treasury, there are  
28 appropriated amounts necessary to fund collection costs and fees  
29 not to exceed 24.34% of the collection or a lesser amount as



1 prescribed by the contract. The amounts appropriated under this  
2 subsection are appropriated from the fund or account to which the  
3 revenues being collected are recorded or dedicated.

4 (3) By November 30, the department of treasury shall submit a  
5 report to the standard report recipients and the senate and house  
6 of representatives standing committees on appropriations. The  
7 report must include all of the following information for the  
8 immediately preceding fiscal year:

9 (a) The name of each law firm and each private collection  
10 agency that the department of treasury contracted with under  
11 subsection (1) or (2).

12 (b) The amount collected under each contract.

13 (c) The costs of collection under each contract.

14 (d) Any other information that is pertinent to determining  
15 whether the authority described in subsection (1) or (2) should be  
16 continued.

17 Sec. 904. (1) The bureau of investments of the department of  
18 treasury may charge an investment service fee against the  
19 applicable retirement funds. The revenue from the investment  
20 service fees charged under this subsection may be expended for  
21 necessary salaries, wages, contractual services, supplies,  
22 materials, equipment, travel, worker's compensation insurance  
23 premiums, and grants to the civil service commission retirement  
24 fund and the state employees' retirement fund. If the bureau of  
25 investments of the department of treasury charges a total amount of  
26 investment service fees under this subsection that is greater than  
27 the aggregate amount appropriated in part 1, the bureau of  
28 investments of the department of treasury shall periodically repay

9 retirement funds' investment portfolios. The state treasurer shall  
10 submit an annual report to the standard report recipients and the  
11 senate and house of representatives standing committees on  
12 appropriations regarding the performance of each portfolio  
13 delineated by investment advisor.

14 (3) Not later than November 30, the department of treasury  
15 shall submit a report to the standard report recipients that  
16 identifies the service fees assessed against each retirement system  
17 under subsection (1) and the methodology used for assessment.

18 Sec. 904a. (1) There is appropriated an amount sufficient to  
19 recognize and pay expenditures for financial services provided by  
20 financial institutions or equivalent vendors that perform these  
21 financial services, including the department of treasury, as  
22 provided under section 1 of 1861 PA 111, MCL 21.181.

23 (2) The appropriations under subsection (1) must be funded by  
24 restricting revenues from common cash interest earnings and  
25 investment earnings in an amount sufficient to cover these  
26 expenditures. If the amounts of common cash interest earnings are  
27 insufficient to cover these expenditures, miscellaneous revenues  
28 must be used to fund the remaining balance of these expenditures.

29 Sec. 905. The municipal finance fee fund is created in the

1 department of treasury as a revolving fund. The department of  
2 treasury shall deposit the fees that the department of treasury

18 tax act, 1987 PA 248, MCL 207.377a.

19           Sec. 910. The disbursement by the department of treasury from  
20 the bottle deposit fund to dealers as required by section 3c(3) of  
21 1976 IL 1, MCL 445.573c, is appropriated.

22           Sec. 911. (1) There is appropriated an amount sufficient to  
23 recognize and pay refundable tax credits, tax refunds, and interest  
24 as provided by law.

25           (2) The appropriations under subsection (1) must be funded by  
26 restricting tax revenue in an amount sufficient to cover these  
27 expenditures.

28           Sec. 912. A plaintiff in a garnishment action involving this  
29 state shall pay to the state treasurer 1 of the following:

1 (a) A fee of \$6.00 at the time a writ of garnishment of  
2 periodic payments is served on the state treasurer, as provided in  
3 section 4012 of the revised judicature act of 1961, 1961 PA 236,  
4 MCL 600.4012.

5 (b) A fee of \$6.00 at the time any other writ of garnishment  
6 is served on the state treasurer. However, the fee must be reduced  
7 to \$5.00 for each writ of garnishment for individual income tax  
8 refunds or credits that is filed electronically.

9 Sec. 913. (1) The department of treasury may contract with  
10 private firms to appraise and, if necessary, appeal the assessments  
11 of senior citizen cooperative housing units. Payment for this  
12 service must be made from the savings that result from the  
13 appraisal or appeal process being conducted by private firms.

14 (2) The department of treasury may use a portion of the funds  
15 appropriated in part 1 for the senior citizen cooperative housing

29 amount equal to the amounts designated for the \_\_\_\_ tax year.

1 Except as otherwise provided in this section, the amount  
2 appropriated does not revert to the general fund and remains in the  
3 state campaign fund. Any amount that remains in the state campaign  
4 fund in excess of \$10,000,000.00 on December 31 reverts to the  
5 general fund.

6 Sec. 916. (1) The department of treasury may make available to  
7 an interested entity a customized list of otherwise unavailable  
8 nonconfidential information regarding unclaimed property that is in  
9 the department of treasury's possession. The department of treasury  
10 shall charge for this information as follows:

11 (a) For 1 to 100,000 records, 2.5 cents per record.

12 (b) For 100,001 or more records, 0.5 cents per record.

13 (2) The revenue received under subsection (1) must be  
14 deposited in the revenue account or fund that is associated with  
15 the applicable unclaimed property.

16 (3) Not later than June 1, the department of treasury shall  
17 submit a report to the standard report recipients and the senate  
18 and house of representatives standing committees on appropriations  
19 that states the amount of revenue received from the sale of the

21 Sec. 917. (1) There is appropriated for write-offs and  
22 advances an amount equal to total write-offs and advances for  
23 departmental programs. The amount appropriated under this  
24 subsection must not exceed current year authorizations that would  
25 otherwise lapse to the general fund.

26 (2) Not later than November 30, the department of treasury  
27 shall submit a report to the standard report recipients. The report  
28 must include all of the following information for the immediately  
29 preceding fiscal year:

1 (a) The amounts appropriated for write-offs and advances under  
2 subsection (1).

3 (b) An explanation for each write-off or advance under  
4 subsection (1).

5 Sec. 919. (1) From funds appropriated in part 1, the  
6 department of treasury may contract with private auditing firms to  
7 audit for and collect unclaimed property due this state in  
8 accordance with the uniform unclaimed property act, 1995 PA 29, MCL  
9 567.221 to 567.265. In addition to the amounts appropriated in part  
10 1 to the department of treasury, there are appropriated amounts  
11 necessary to fund auditing and collection costs and fees not to  
12 exceed 12% of the collections or a lesser amount as prescribed by  
13 the applicable contract. The appropriation to fund collection costs  
14 and fees for the auditing and collection of unclaimed property due

5 (b) Post the list produced under subdivision (a) on the  
6 department of treasury's public website.

7 Sec. 921. From the funds appropriated in part 1, the  
8 department of treasury shall, for each revenue administrative  
9 bulletin, administrative rule that involves tax administration or  
10 collection, and notice interpreting a change in law, submit a  
11 notification to every member of the legislature. The department of  
12 treasury shall submit the notification not later than 3 days after  
13 the department of treasury posts the notification. Each

26 residence audits under the general property tax act, 1893 PA 206,  
27 MCL 211.1 to 211.155.

28 (2) Not later than December 31, the department of treasury  
29 shall submit a report to the standard report recipients that



1 includes the amount of exemptions denied and the revenue received  
2 under the program described in subsection (1) for the immediately  
3 preceding fiscal year.

4 Sec. 927. The department of treasury shall submit a progress  
5 report regarding essential service assessment audits to the  
6 standard report recipients. The report must include all of the  
7 following:

8 (a) The number of audits.

9 (b) The revenue generated from the audits.

10 (c) The number of complaints received by the department of  
11 treasury related to the audits.

12 Sec. 928. The department of treasury may provide receipt,  
13 check and cash processing, data, collection, investment, fiscal  
14 agent, levy and check cost assessment, writ of garnishment, and  
15 other user services on a contractual basis for other principal  
16 executive departments and state agencies. Funds for the services  
17 provided are appropriated and must be expended for salaries, wages,  
18 fees, supplies, and equipment necessary to provide the services.  
19 Money in the fund that is unobligated at the end of the fiscal year  
20 lapses to the general fund.

21 Sec. 930. (1) The department of treasury shall provide  
22 accounts receivable collections services to other principal  
23 executive departments and state agencies in accordance with 1927 PA  
24 375, MCL 14.131 to 14.134, or to a city with which the department  
25 of treasury has contracted to provide tax administration services.

15 retirement fund.

16           Sec. 934. (1) The department of treasury may expend revenues  
17 received under the hospital finance authority act, 1969 PA 38, MCL  
18 331.31 to 331.84, the shared credit rating act, 1985 PA 227, MCL  
19 141.1051 to 141.1076, the higher education facilities authority  
20 act, 1969 PA 295, MCL 390.921 to 390.934, the Michigan public  
21 educational facilities authority, Executive Reorganization Order  
22 No. 2002-3, MCL 12.192, the Michigan tobacco settlement finance  
23 authority act, 2005 PA 226, MCL 129.261 to 129.279, the land bank  
24 fast track act, 2003 PA 258, MCL 124.751 to 124.774, part 505 of  
25 the natural resources and environmental protection act, 1994 PA  
26 451, MCL 324.50501 to 324.50522, the state housing development

5 Sec. 938. Revenue collected in the qualified heavy equipment  
6 rental personal property exemption reimbursement fund is  
7 appropriated and must be distributed in accordance with section 9  
8 of the qualified heavy equipment rental personal property specific  
9 tax act, 2022 PA 35, MCL 211.1129.

10 Sec. 939. (1) The department of treasury shall distribute the  
11 funds appropriated in part 1 for public safety trust fund as  
12 follows:

13 (a) 6.5% of the amount must be distributed to the MDHHS to  
14 create and administer a grant program to provide grants to cities,  
15 villages, townships, and counties for the purpose of advancing  
16 public health and intervention solutions to community violence.

17 (b) 2.0% of the amount must be distributed to the crime  
18 victim's rights fund created under section 4 of 1989 PA 196, MCL

14           (b) "Chemical weapon" means a munition or device that is

17 Sec. 947. It is the intent of the legislature that financial  
18 independence teams cooperate with the financial responsibility  
19 section to coordinate and streamline efforts in identifying and  
20 addressing fiscal emergencies in school districts and intermediate  
21 school districts.

22 Sec. 949. (1) From the funds appropriated in part 1, the  
23 department of treasury may contract with private agencies to  
24 prevent the disbursement of fraudulent tax refunds. In addition to  
25 the amounts appropriated in part 1 to the department of treasury,  
26 there are appropriated amounts necessary to pay the costs of the

16 whether the authority under subsection (1) should be continued.

17 Sec. 949a. From the funds appropriated in part 1 for city  
18 income tax administration program, the department of treasury may  
19 expand its individual income tax administration for any additional  
20 cities that enter into service-level agreements with the department  
21 of treasury for this purpose. In addition to the funds appropriated  
22 in part 1, any additional local funds received as part of the  
23 service-level agreements are appropriated to the department for  
24 staffing and administration of the program.

25 Sec. 949b. Tax capture revenues collected in accordance with  
26 written agreements under the good jobs for Michigan program and  
27 transferred from the general fund for deposit into the good jobs  
28 for Michigan fund, including tax capture revenues collected for  
29 calculated payments from the good jobs for Michigan fund to

1 authorized businesses and distributions to the MSF for  
2 administrative expenses, are appropriated in accordance with  
3 chapter 8D of the Michigan strategic fund act, 1984 PA 270, MCL  
4 125.2090g to 125.2090j.

5 Sec. 949c. From the funds appropriated in part 1, funds must  
6 be expended in coordination with the department of agriculture and  
7 rural development to improve the timely processing and issuance of  
8 tax credits from the Michigan's farmland and open space  
9 preservation program created under section 36109 of the natural  
10 resources and environmental protection act, 1994 PA 451, MCL  
11 324.36109, for the Michigan's farmland and open space preservation  
12 program under parts 361 and 362 of the natural resources and  
13 environmental protection act, 1994 PA 451, MCL 324.36101 to  
14 324.36116 and 324.36201 to 324.36207, including, but not limited  
15 to, all of the following:

16 (a) Timely review of mailed applications and paperwork.

17 (b) Timely and proactive communications to applicants  
18 regarding the status of the applicant's application.

19 (c) A clear and understood timeline for the issuance of any  
20 tax credits.

21 Sec. 949d. (1) From the funds appropriated in part 1 for  
22 financial review commission, the department of treasury shall  
23 continue financial review commission efforts in the current fiscal  
24 year. The purpose of the funding is to cover ongoing costs  
25 associated with the operation of the commission.

26 (2) The department of treasury shall identify specific  
27 outcomes and performance measures for this initiative, including,  
28 but not limited to, the department of treasury's ability to perform  
29 a critical fiscal review to ensure the city of Detroit does not

1 reenter distress following its exit from bankruptcy and to ensure  
2 that the community district does not enter distress and maintains a  
3 balanced budget.

4 (3) Not later than March 15, the department of treasury shall  
5 submit a report to the standard report recipients that includes  
6 both of the following:

7 (a) A description of the specific outcomes and measures  
8 required in subsection (1).

9 (b) The results and data related to these outcomes and  
10 measures.

11 Sec. 949e. From the funds appropriated in part 1 for the state  
12 essential services assessment program, the department of treasury  
13 shall administer the state essential services assessment program.  
14 The purpose of the program is to provide a phased-in replacement of  
15 locally collected personal property taxes on eligible manufacturing  
16 personal property. The program must provide the department of  
17 treasury with the ability to collect the state essential services  
18 assessment.

19 Sec. 949f. Revenue from the tobacco products tax act, 1993 PA  
20 327, MCL 205.421 to 205.436, related to counties with a population  
21 of more than 2,000,000 according to the most recent federal  
22 decennial census is appropriated and must be distributed in  
23 accordance with section 12(4)(d) of the tobacco products tax act,  
24 1993 PA 327, MCL 205.432.

25 Sec. 949h. Revenue from part 6 of the medical marihuana  
26 facilities licensing act, 2016 PA 281, MCL 333.27601 to 333.27605,  
27 is appropriated and must be distributed in accordance with part 6  
28 of the medical marihuana facilities licensing act, 2016 PA 281, MCL  
29 333.27601 to 333.27605.

1           Sec. 949i. Revenue from the Michigan Regulation and Taxation  
2 of Marihuana Act, 2018 IL 1, MCL 333.27951 to 333.27967, is  
3 appropriated and must be distributed in accordance with the  
4 Michigan Regulation and Taxation of Marihuana Act, 2018 IL 1, MCL  
5 333.27951 to 333.27967.

6           Sec. 949j. All funds in the wrongful imprisonment compensation  
7 fund created in the wrongful imprisonment compensation act, 2016 PA  
8 343, MCL 691.1751 to 691.1757, are appropriated and available for  
9 expenditure. Expenditures are limited to support wrongful  
10 imprisonment compensation payments under section 6 of the wrongful  
11 imprisonment compensation act, 2016 PA 343, MCL 691.1756.

12           Sec. 949k. There is appropriated an amount equal to the tax  
13 captured revenues due under approved transformational brownfield  
14 plans created under the brownfield redevelopment financing act,  
15 1996 PA 381, MCL 125.2651 to 125.2670.

16           Sec. 949m. From the funds appropriated in part 1, the Michigan  
17 infrastructure council shall plan, conduct, and contract for asset  
18 management improvement activities, including, but not limited to,  
19 any of the following:

20           (a) Infrastructure data collection activities.

21           (b) Asset manager training.

22           (c) Development of a 30-year asset management plan for this  
23 state.

24           (d) Assistance in asset management improvement projects,  
25 including maintaining an asset management portal.

26           (e) Any other projects that promote improved asset management  
27 for infrastructure in this state.

28           Sec. 949n. In addition to funding appropriated in part 1, the  
29 department of treasury is authorized to issue payments in

1 compliance with the fostering futures scholarship trust fund act,  
2 2008 PA 525, MCL 722.1021 to 722.1031, including any money received  
3 as gifts or donations to the fostering futures scholarship trust  
4 fund.

6 **REVENUE SHARING**

7 Sec. 950. The department of treasury shall distribute the  
8 funds appropriated in part 1 for constitutional revenue sharing to  
9 cities, villages, and townships, as required under section 10 of  
10 article IX of the state constitution of 1963. Revenue collected in  
11 accordance with section 10 of article IX of the state constitution  
12 of 1963 in excess of the amount appropriated in part 1 for  
13 constitutional revenue sharing is appropriated for distribution to  
14 cities, villages, and townships, on a population basis as required  
15 under section 10 of article IX of the state constitution of 1963.

16 Sec. 951. (1) The funds appropriated in part 1 for revenue  
17 sharing trust fund shall be distributed by the department of  
18 treasury to cities, villages, townships, and counties as follows:

19 (a) To cities, villages, and townships that were eligible to  
20 receive funding under section 952(1) of article 5 of 2023 PA 119,  
21 in an amount equal to 52.87% of the amount appropriated in part 1  
22 for revenue sharing trust fund, distributed to each city, village,  
23 or township in the same proportion that each was eligible to  
24 receive under section 952(1) of article 5 of 2023 PA 119.

25 (b) To cities, villages, and townships that were not eligible  
26 to receive funding under section 952(1) of article 5 of 2023 PA  
27 119, in an amount equal to 1.00% of the amount appropriated in part  
28 1 for revenue sharing trust fund, distributed to each city,  
29 village, or township on a per capita basis based on the most recent

1 federal decennial census.

2 (c) To counties, in an amount equal to 46.13% of the amount  
3 appropriated in part 1 for revenue sharing trust fund, distributed  
4 to each county in the same proportion that each was eligible to  
5 receive under sections 952(2) and 955 of article 5 of 2023 PA 119.  
6 If a county was eligible to receive payments under section 11 of  
7 the Glenn Steil state revenue sharing act of 1971, 1971 PA 140, MCL  
8 141.911, for only a partial fiscal year, the amount distributed to  
9 the county under this subdivision must be adjusted to treat the  
10 county as if it were eligible to receive the revenue sharing  
11 payments for the entire fiscal year.

12 (2) If a city, village, township, or county is eligible to  
13 receive a distribution under subsection (1), the distribution must  
14 be made on the last business day of October, December, February,  
15 April, June, or August, as applicable.

16 Sec. 956. (1) From the funds appropriated in part 1 for  
17 financially distressed cities, villages, or townships, the  
18 department of treasury shall create and operate a grant program to  
19 provide grants to cities, villages, and townships that have 1 or  
20 more conditions that indicate probable financial distress, as  
21 determined by the department of treasury.

22 (2) A city, village, or township with 1 or more conditions  
23 that indicate probable financial distress may apply in a manner  
24 determined by the department of treasury for a grant to pay for  
25 specific projects or services that move the city, village, or  
26 township toward financial stability.

27 (3) A city, village, or township must use a grant to do 1 or  
28 more of the following:

29 (a) Make payments to reduce unfunded accrued liability.

1 (b) Repair or replace critical infrastructure and equipment  
2 owned or maintained by the city, village, or township.

3 (c) Reduce debt obligations.

4 (d) Pay for costs associated with a transition to shared  
5 services with another jurisdiction.

6 (e) Administer any other project that moves the city, village,  
7 or township toward financial stability.

8 (4) The department of treasury shall not award more than  
9 \$2,000,000.00 to a city, village, or township under this section.

10 (5) Not later than March 31, the department of treasury shall  
11 submit a report to the standard report recipients that includes all  
12 of the following information for each grant:

13 (a) The grant recipient.

14 (b) The date the grant was approved.

15 (c) The amount of the grant.

16 (d) A description of the project or projects for which the  
17 grant will be used.

18 (6) The unexpended funds appropriated in part 1 for  
19 financially distressed cities, villages, or townships are  
20 designated as a work project appropriation, and any unencumbered or  
21 unallotted funds shall not lapse at the end of the fiscal year and  
22 shall be available for expenditure for projects under this section  
23 until the projects have been completed. The following is in  
24 compliance with section 451a of the management and budget act, 1984  
25 PA 431, MCL 18.1451a:

26 (a) The purpose of the project is to provide assistance to  
27 financially distressed cities, villages, and townships under this  
28 section.

29 (b) The projects will be accomplished by grants to cities,



1 villages, and townships approved by the department of treasury.

2 (c) The total estimated cost of all projects is \$2,500,000.00.

3 (d) The tentative completion date is September 30, 2029.

4  
5 **BUREAU OF STATE LOTTERY**

6 Sec. 960. In addition to the funds appropriated in part 1 to  
7 the bureau of state lottery, there is appropriated from state  
8 lottery fund revenues the amount necessary for, and directly  
9 related to, implementing and operating lottery games under the  
10 McCauley-Traxler-Law-Bowman-McNeely lottery act, 1972 PA 239, MCL  
11 432.1 to 432.47, and activities under the Traxler-McCauley-Law-  
12 Bowman bingo act, 1972 PA 382, MCL 432.101 to 432.152, including  
13 expenditures for contractually mandated payments for vendor  
14 commissions, contractually mandated payments for instant tickets  
15 intended for resale, the contractual costs of providing and  
16 maintaining the online system communications network, and incentive  
17 and bonus payments to lottery retailers.

18 Sec. 964. For the bureau of state lottery, there is  
19 appropriated 1% of the lottery's immediately preceding fiscal  
20 year's gross sales for promotion and advertising.

21  
22 **CASINO GAMING**

23 Sec. 970. As used in sections 971 to 979:

24 (a) "Compulsive gaming prevention fund" means the compulsive  
25 gaming prevention fund created in section 3 of the compulsive  
26 gaming prevention act, 1997 PA 70, MCL 432.253.

27 (b) "Fantasy contest fund" means the fantasy contest fund  
28 created in section 16 of the fantasy contests consumer protection  
29 act, 2019 PA 157, MCL 432.516.

1 (c) "First responder presumed coverage fund" means the first  
2 responder presumed coverage fund created in section 405 of the  
3 worker's disability compensation act of 1969, 1969 PA 317, MCL  
4 418.405.

5 (d) "Internet gaming fund" means the internet gaming fund  
6 created in section 16 of the lawful internet gaming act, 2019 PA  
7 152, MCL 432.316.

8 (e) "Internet sports betting fund" means the internet sports  
9 betting fund created in section 16 of the lawful sports betting  
10 act, 2019 PA 149, MCL 432.416.

11 Sec. 971. (1) From the revenue collected by the Michigan  
12 gaming control board from the total annual assessment of each  
13 casino licensee, \$2,000,000.00 is appropriated and must be  
14 deposited in the compulsive gaming prevention fund as described in  
15 section 12a(5) of the Michigan Gaming Control and Revenue Act, 1996  
16 IL 1, MCL 432.212a.

17 (2) From the money remaining in the internet sports betting  
18 fund after expenditures for costs incurred by the Michigan gaming  
19 control board for regulating and enforcing internet sports betting  
20 under the lawful sports betting act, 2019 PA 149, MCL 432.401 to  
21 432.419, \$1,000,000.00 is appropriated from the internet sports  
22 betting fund and must be deposited in the compulsive gaming  
23 prevention fund as described in section 16(4) of the lawful sports  
24 betting act, 2019 PA 149, MCL 432.416. After these disbursements  
25 have been made, \$2,000,000.00 is appropriated from the internet  
26 sports betting fund and must be deposited in the first responder  
27 presumed coverage fund as described in section 16(4) of the lawful  
28 sports betting act, 2019 PA 149, MCL 432.416.

29 (3) From the money remaining in the internet gaming fund after

1 expenditures for costs incurred by the board for regulating and  
2 enforcing internet gaming under the lawful internet gaming act,  
3 2019 PA 152, MCL 432.301 to 432.322, and the costs of administering  
4 and enforcing millionaire party activity authorized by the Traxler-  
5 McCauley-Law-Bowman bingo act, 1972 PA 382, MCL 432.101 to 432.152,  
6 \$3,000,000.00 is appropriated from the internet gaming fund and  
7 must be deposited in the compulsive gaming prevention fund as  
8 described in section 16(4) of the lawful internet gaming act, 2019  
9 PA 152, MCL 432.316, except as provided in section 15(2) of the  
10 lawful internet gaming act, 2019 PA 152, MCL 432.315. After these  
11 disbursements have been made, \$2,000,000.00 is appropriated from  
12 the internet gaming fund and must be deposited in the first  
13 responder presumed coverage fund as described in section 16(4) of  
14 the lawful internet gaming act, 2019 PA 152, MCL 432.316.

15 Sec. 972. After all other required expenditures described in  
16 section 16(3) of the fantasy contests consumer protection act, 2019  
17 PA 157, MCL 432.516, section 16(4) of the lawful internet gaming  
18 act, 2019 PA 152, MCL 432.316, and section 16(4) of the lawful  
19 sports betting act, 2019 PA 149, MCL 432.416 are made, any money  
20 remaining in the fantasy contest fund, internet gaming fund, and  
21 internet sports betting fund is appropriated and must be deposited  
22 in the state school aid fund as described in section 16(3)(b) of  
23 the fantasy contests consumer protection act, 2019 PA 157, MCL  
24 432.516, section 16(4) of the lawful internet gaming act, 2019 PA  
25 152, MCL 432.316, and section 16(4) of the lawful sports betting  
26 act, 2019 PA 149, MCL 432.416.

27 Sec. 973. (1) Funds appropriated in part 1 for local  
28 government programs may be used to provide assistance to a local  
29 revenue sharing board referenced in an agreement authorized by the

1 Indian gaming regulatory act, Public Law 100-497.

2 (2) A local revenue sharing board described in subsection (1)  
3 shall comply with the open meetings act, 1976 PA 267, MCL 15.261 to  
4 15.275, and the freedom of information act, 1976 PA 442, MCL 15.231  
5 to 15.246.

6 (3) A county treasurer may receive and administer funds on  
7 behalf of a local revenue sharing board. Funds appropriated in part  
8 1 for local government programs may be used to audit local revenue  
9 sharing board funds held by a county treasurer. This section does  
10 not limit the ability of local units of government to enter into  
11 agreements with federally recognized Indian tribes to provide  
12 financial assistance to local units of government or to jointly  
13 provide public services.

14 (4) A local revenue sharing board described in subsection (1)  
15 shall comply with all applicable provisions of any agreement  
16 authorized by the Indian gaming regulatory act, Public Law 100-497,  
17 in which the local revenue sharing board is referenced, including,  
18 but not limited to, the disbursement of tribal casino payments  
19 received in accordance with applicable provisions of the tribal-  
20 state class III gaming compact under which those funds are

22 (5) The director of the MDSP and the executive director of the  
23 Michigan gaming control board may assist the local revenue sharing  
24 boards in determining allocations to be made to local public safety  
25 organizations.

26 (6) Not later than September 30, the Michigan gaming control  
27 board shall submit a report to the standard report recipients and  
28 the senate and house of representatives standing committees on  
29 appropriations on the receipts and distribution of revenues by

1 local revenue sharing boards.

2 Sec. 974. If revenues collected in the state services fee fund  
3 created in section 12a of the Michigan Gaming Control and Revenue  
4 Act, 1996 IL 1, MCL 432.212a, are less than the amounts  
5 appropriated from the state services fee fund, available revenues  
6 must be used to fully fund the appropriation in part 1 for casino  
7 gaming regulation activities before distributions are made to other  
8 state departments and agencies. If the remaining revenue in the  
9 state services fee fund is insufficient to fully fund  
10 appropriations to other state departments or agencies, the  
11 shortfall must be distributed proportionally among those  
12 departments and agencies.

13 Sec. 975. It is the intent of the legislature that, in  
14 expending the funds appropriated in part 1 for advertising for  
15 responsible gaming, the Michigan gaming control board coordinate  
16 with MDHHS on strategies to support addiction prevention and  
17 education efforts in addition to advertising for responsible  
18 gaming. Not later than September 1, the Michigan gaming control  
19 board shall submit a report to the standard report recipients on

1 development fund created in section 20 of the horse racing law of

3 appropriations, must be reduced proportionately if revenues to the  
4 equine industry development fund decline during the current fiscal  
5 year to a level lower than the amount appropriated in part 1.

6 Sec. 978. The Michigan gaming control board shall use actual  
7 expenditure data in determining the actual regulatory costs of  
8 conducting racing dates and shall submit a report of that data to  
9 the standard report recipients and the senate and house of  
10 representatives appropriations subcommittees on agriculture. The  
11 Michigan gaming control board may not be reimbursed for more than  
12 the actual regulatory cost of conducting race dates. Before the  
13 Michigan gaming control board reduces the number of authorized race  
14 dates under this section, the executive director of the Michigan  
15 gaming control board shall provide notice to the certified  
16 horsemen's organizations with an opportunity to respond with  
17 alternatives. In determining actual costs, the Michigan gaming  
18 control board shall take into account that each specific breed of  
19 horse may require different regulatory mechanisms.

20 Sec. 979. From the funds appropriated in part 1 for  
21 millionaire party regulation, the Michigan gaming control board may  
22 receive and expend internet gaming fund revenue in an amount that  
23 is not more than the amount appropriated in part 1 for necessary  
24 expenses incurred in the licensing and regulation of millionaire  
25 parties under article 2 of the Traxler-McCauley-Law-Bowman bingo  
26 act, 1972 PA 382, MCL 432.132 to 432.152. Any unused internet  
27 gaming fund revenues are subject to the distribution requirements  
28 in section 16 of the lawful internet gaming act, 2019 PA 152, MCL  
29 432.316. Not later than March 1, the Michigan gaming control board

1 shall submit a report to the standard report recipients that  
2 includes all of the following:

3 (a) The total expenditures related to the licensing and  
4 regulating of millionaire parties.

5 (b) The steps taken to ensure charities are receiving revenue  
6 due to them.

7 (c) A description of the progress on promulgating rules to  
8 ensure compliance with the Traxler-McCauley-Law-Bowman bingo act,  
9 1972 PA 382, MCL 432.101 to 432.152.

10 (d) Any enforcement actions taken.

11

12 **ONE-TIME APPROPRIATIONS**

13 Sec. 992. (1) The election administration support fund is  
14 created in the state treasury.

15 (2) Any unexpended funds in the election administration  
16 support fund must be carried forward and are available for  
17 expenditure under this section.

18 (3) Funds may be spent from the election administration  
19 support fund only on appropriation, or legislative transfer  
20 pursuant to section 393(2) of the management and budget act, 1984  
21 PA 431, MCL 18.1393.

22 (4) The state treasurer may receive money or other assets from  
23 any source for deposit in the election administration support fund.  
24 The state treasurer shall direct the investment of the election  
25 administration support fund. The state treasurer shall credit to  
26 the election administration support fund interest and earnings from  
27 the election administration support fund.

28 (5) Funds in the election administration support fund at the  
29 close of the fiscal year remain in the election administration

1 support fund and do not lapse to the general fund.

2 (6) Funds appropriated in part 1 for election administration  
3 support fund must be deposited in the election administration  
4 support fund.

5 Sec. 994. (1) The funds appropriated in part 1 for the secure  
6 retirement for small businesses that do not currently provide  
7 retirement options for private sector workers must not be spent or  
8 otherwise distributed unless House Bill No. 5461 of the 102nd  
9 Legislature is enacted into law. The funds must be used to  
10 implement House Bill No. 5461 of the 102nd Legislature and may be  
11 used to create a state-managed retirement plan marketplace for  
12 small businesses as provided for under House Bill No. 5461 of the  
13 102nd Legislature.

14 (2) The department of treasury shall submit a report to the  
15 standard report recipients and the chairpersons of the senate and  
16 house of representative standing committees on appropriations that  
17 includes, but is not limited to, the number of participating  
18 employers and participating employees in the program.

19 (3) The department of treasury shall develop guidelines and  
20 definitions for the implementation of this section that comply with  
21 House Bill No. 5461 of the 102nd Legislature.

22 (4) The department of treasury shall establish and implement  
23 oversight guidelines for benefit providers participating in the  
24 program that include measures to investigate and provide corrective  
25 action against instances of discrimination, predatory practices,  
26 and fraud.

27

28 **STATE BUILDING AUTHORITY**

29 Sec. 1100. (1) Subject to section 242 of the management and



1 budget act, 1984 PA 431, MCL 18.1242, and on the approval of the  
2 state building authority, the department of treasury may expend  
3 from the general fund of this state during the fiscal year an  
4 amount necessary to meet the cash flow requirements of those state  
5 building authority projects solely for lease to a state agency  
6 identified in both part 1 and this section, and for which state  
7 building authority bonds or notes have not been issued, and for the  
8 sole acquisition by the state building authority of equipment and  
9 furnishings for lease to a state agency as permitted by 1964 PA  
10 183, MCL 830.411 to 830.425, for which the issuance of bonds or  
11 notes is authorized by an appropriations PA that is effective for  
12 the immediately preceding fiscal year. Any general fund advances  
13 for which state building authority bonds have not been issued must  
14 bear an interest cost to the state building authority at a rate  
15 that is not greater than the rate earned by the state treasurer's  
16 common cash fund during the period in which the advances are  
17 outstanding and are repaid to the general fund of this state.

18 (2) On sale of bonds or notes for the projects identified in  
19 part 1 or for equipment as authorized by an appropriations PA and  
20 in this section, the state building authority shall credit the  
21 general fund of this state an amount equal to the amount expended  
22 from the general fund plus interest, if any, as described in this  
23 section.

24 (3) For state building authority projects for which bonds or  
25 notes have been issued and on the request of the state building  
26 authority, the state treasurer shall make advances without interest  
27 from the general fund as necessary to meet cash flow requirements  
28 for the projects. The state building authority shall reimburse the  
29 state treasurer for the advances when the investments earmarked for

1 the financing of the projects mature.

2 (4) If a project identified in part 1 is terminated after  
3 final design is complete, advances made on behalf of the state  
4 building authority for the costs of final design must be repaid to  
5 the general fund in a manner recommended by the director of the  
6 state building authority.

7 Sec. 1102. (1) The state building authority shall not release  
8 state building authority funding to a university or community  
9 college to finance the construction or renovation of a facility  
10 that collects revenue in excess of money required for the operation  
11 of that facility unless the university or community college agrees  
12 to use that excess revenue to reimburse the state building  
13 authority. The excess revenue received by the state building  
14 authority as reimbursement must be credited to the general fund to  
15 offset rent obligations associated with the retirement of bonds  
16 issued for the applicable facility. The auditor general shall  
17 annually identify and audit the facilities that are subject to this  
18 section. Costs associated with the administration of the audit must  
19 be charged against money received by the state building authority  
20 as reimbursement under this section.

21 (2) As used in this section, "revenue" includes state  
22 appropriations, facility opening money, other state aid, indirect  
23 cost reimbursement, and other revenue generated by the activities  
24 of the facility.

25 Sec. 1103. Not later than October 15, the state building  
26 authority shall submit a report to the standard report recipients  
27 and the JCOS regarding the status of construction projects  
28 associated with state building authority bonds as of the end of the  
29 immediately preceding fiscal year. Not later than 30 days after a

1 refinancing or restructuring bond issue is sold, the state building  
 2 authority shall submit a report to the standard report recipients  
 3 and the JCOS regarding the status of construction projects  
 4 associated with that bond issue. Each report must include all of  
 5 the following:

6 (a) A list of all completed construction projects for which  
 7 state building authority bonds have been sold, and which bonds are  
 8 currently active.

9 (b) A list of all projects under construction for which sale  
 10 of state building authority bonds is pending.

11 (c) A list of all projects authorized for construction or  
 12 identified in an appropriations act for which approval of  
 13 schematic/preliminary plans or total authorized cost is pending  
 14 that have state building authority bonds identified as a source of  
 15 financing.
