HOUSE BILL NO. 4209

March 08, 2023, Introduced by Reps. Neyer, Schuette, Kunse, Prestin, Harris, Alexander, Beson, St. Germaine, Martin, Markkanen, Hoadley, DeBoer and Steele and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled "The revised school code,"

by amending sections 1278a, 1278b, and 1278c (MCL 380.1278a, 380.1278b, and 380.1278c), sections 1278a and 1278b as amended by 2022 PA 105 and section 1278c as amended by 2018 PA 242, and by adding section 1278f.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 1278a. (1) Except as otherwise provided in this section,

or section 1278b, or section 1278f, the board of a school district

or board of directors of a public school academy shall not award a

- high school diploma to a pupil unless the pupil meets all of the
 following:
- 3 (a) Has successfully completed all of the following credit
 4 requirements of the Michigan merit standard before graduating from
 5 high school:
- 6 (i) At least 4 credits in mathematics that are aligned with 7 subject area content expectations developed by the department and 8 approved by the state board under section 1278b, including 9 completion of at least algebra I, geometry, and algebra II, or an 10 integrated sequence of this course content that consists of 3 credits, and an additional mathematics credit, such as 11 12 trigonometry, statistics, precalculus, calculus, applied math, 13 accounting, business math, a retake of algebra II, or, for only 14 pupils entering grade 8 before 2023, a course in financial literacy 15 as described in section 1165. A pupil may complete algebra II over 2 years with 2 credits awarded or over 1.5 years with 1.5 credits 16 17 awarded for the purposes of this section and section 1278b. A pupil 18 also may partially or fully fulfill the algebra II requirement by 19 completing a department-approved formal career and technical 20 education program or curriculum, such as a program or curriculum in 21 electronics, machining, construction, welding, engineering, 22 computer science, or renewable energy, and in that program or 23 curriculum successfully completing the same content as the algebra 24 II benchmarks assessed on the department-prescribed state high 25 school assessment, as determined by the department. The department 26 shall post on its website quidelines for implementation of the 27 immediately preceding sentence. Each pupil must successfully 28 complete at least 1 mathematics course during his or her final year

of high school enrollment. This subparagraph does not require

29

1 completion of mathematics courses in any particular sequence.

2 (ii) At least 3 credits in social science that are aligned with 3 subject area content expectations developed by the department and 4 approved by the state board under section 1278b, including 5 completion of at least 1 credit in United States history and geography, 1 credit in world history and geography, 1/2 credit in 6 7 economics, and the civics course described in section 1166(2). For only pupils entering grade 8 before 2023, the 1/2-credit economics 8 9 requirement may be satisfied by completion of at least a 1/2-credit 10 course in personal economics that includes a financial literacy component as described in section 1165, if that course covers the 11 12 subject area content expectations for economics developed by the 13 department and approved by the state board under section 1278b. The 14 1/2 credit in economics required under this subparagraph cannot be 15 fulfilled by completion of the 1/2 credit course in personal 16 finance described in subsection (3).

(iii) At least 1 credit in subject matter that includes both health and physical education aligned with guidelines developed by the department and approved by the state board under section 1278b, or at least 1/2 credit in health aligned with guidelines developed by the department and approved by the state board under section 1278b and at least 1/2 credit awarded by the school district or public school academy for approved participation in extracurricular athletics or other extracurricular activities involving physical activity.

(iv) At least 1 credit in visual arts, performing arts, or applied arts, as defined by the department, that is aligned with guidelines developed by the department and approved by the state board under section 1278b. A school district or public school

- 1 academy is strongly encouraged to offer visual arts and performing
 2 arts courses.
- 3 (v) The credit requirements specified in section 1278b(1).
- 4 (b) Meets the online course or learning experience requirement
 5 of this subsection. A school district or public school academy
 6 shall provide the basic level of technology and internet access
 7 required by the state board to complete the online course or
 8 learning experience. For a pupil to meet this requirement, the
 9 pupil must meet either of the following, as determined by the
- (i) Has successfully completed at least 1 course or learningexperience that is presented online, as defined by the department.

school district or public school academy:

- (ii) The pupil's school district or public school academy has integrated an online experience throughout the high school curriculum by ensuring that each teacher of each course that provides the required credits of the Michigan merit curriculum has integrated an online experience into the course.
- (2) Except as otherwise provided in this section, and in addition to the requirements under subsection (1), the board of a school district or board of directors of a public school academy shall not award a high school diploma to a pupil unless the pupil has successfully completed during grades K to 12 at least 2 credits that are grade-appropriate in a language other than English or course work or other learning experiences that are substantially equivalent to 2 credits in a language other than English, based on guidelines developed by the department. A pupil may partially or fully fulfill 1 credit of this requirement by completing a department-approved formal career and technical education program or curriculum or by completing visual or performing arts

- 1 instruction that is in addition to the requirements under
- 2 subsection (1)(a)(iv). The board of a school district or board of
- 3 directors of a public school academy is strongly encouraged to
- 4 ensure that all pupils complete at least 1 credit in a language
- 5 other than English in grades K to 6. For the purposes of this
- 6 subsection, both of the following apply:
- 7 (a) American Sign Language is considered to be a language8 other than English.
- 9 (b) The pupil may meet all or part of this requirement with10 online course work.
- 11 (3) Beginning with pupils entering grade 8 in 2023, the board
- 12 of a school district or board of directors of a public school
- 13 academy shall not award a high school diploma to a pupil unless the
- 14 pupil completes a 1/2 credit course in personal finance that aligns
- 15 with subject area content expectations developed by the department
- 16 and approved by the state board under section 1278b. The 1/2 credit
- 17 course in personal finance must fulfill 1/2 credit of mathematics
- 18 required under subsection (1)(a)(i), 1/2 credit of visual arts,
- 19 performing arts, or applied arts required under subsection
- 20 (1) (a) (iv), or 1/2 credit of a language other than English required
- 21 under subsection (2), as determined by the board of the school
- 22 district or board of directors of the public school academy in
- 23 which the pupil is enrolled. The 1/2 credit course in personal
- 24 finance required under this subsection may be fulfilled through a
- 25 department-approved formal career and technical education program
- 26 or curriculum that aligns with the subject area content
- 27 expectations developed by the department and approved by the state
- 28 board for the credit under section 1278b.
- 29 (4) The requirements under this section and section 1278b for

- 1 a high school diploma are in addition to any local requirements
- 2 imposed by the board of a school district or board of directors of
- 3 a public school academy. The board of a school district or board of
- 4 directors of a public school academy, as a local requirement for a
- 5 high school diploma, may require a pupil to complete the Michigan
- 6 merit examination under section 1279g or may require a pupil to
- 7 participate in the MIAccess assessments if appropriate for the
- 8 pupil.
- 9 (5) For the purposes of this section and section 1278b, all of 10 the following apply:
- 11 (a) A—Except as otherwise provided in this section, section
 12 1278b, or section 1278f, a pupil is considered to have completed a
- 13 credit if the pupil successfully completes the subject area content
- 14 expectations or guidelines developed by the department that apply
- 15 to the credit. For a career and technical education credit, a
- 16 school district or public school academy may supplement those
- 17 content expectations and guidelines with additional guidelines
- 18 developed by the school district or public school academy.
- 19 (b) A school district or public school academy shall base its
- 20 determination of whether a pupil has successfully completed the
- 21 subject area content expectations or guidelines developed by the
- 22 department that apply to a credit at least in part on the pupil's
- 23 performance on assessments developed or selected by the department
- 24 or on 1 or more assessments developed or selected by the school
- 25 district or public school academy that measure a pupil's
- 26 understanding of the subject area content expectations or
- 27 guidelines that apply to the credit.
- 28 (c) A school district or public school academy shall also
- 29 grant a pupil a credit if the pupil earns a qualifying score, as

- 1 determined by the department, on assessments developed or selected
- 2 for the subject area by the department or the pupil earns a
- 3 qualifying score, as determined by the school district or public
- 4 school academy, on 1 or more assessments developed or selected by
- 5 the school district or public school academy that measure a pupil's
- 6 understanding of the subject area content expectations or
- 7 quidelines that apply to the credit.
- **8** (6) If a high school is designated by the superintendent of
- 9 public instruction as a specialty school and the high school meets
- 10 the requirements of subsection (7), the pupils of the high school
- 11 are not required to successfully complete the 4 credits in English
- 12 language arts required under section 1278b(1)(a) or the 3 credits
- 13 in social science required under subsection (1)(a)(ii) and the
- 14 school district or public school academy is not required to ensure
- 15 that each pupil is offered the curriculum necessary for meeting
- 16 those English language arts or social science credit requirements.
- 17 The superintendent of public instruction may designate up to 15
- 18 high schools that meet the requirements of this subsection as
- 19 specialty schools. Subject to this maximum number, the
- 20 superintendent of public instruction shall designate a high school
- 21 as a specialty school if the superintendent of public instruction
- 22 finds that the high school meets all of the following criteria:
- (a) The high school incorporates a significant reading and
- 24 writing component throughout its curriculum.
- 25 (b) The high school uses a specialized, innovative, and
- 26 rigorous curriculum in such areas as performing arts, foreign
- 27 language, extensive use of internships, or other learning
- 28 innovations that conform to pioneering innovations among other
- 29 leading national or international high schools.

1 (7) A high school that is designated by the superintendent of 2 public instruction as a specialty school under subsection (6) is 3 only exempt from requirements as described under subsection (6) as 4 long as the superintendent of public instruction finds that the

high school continues to meet all of the following requirements:

6 (a) The high school clearly states to prospective pupils and 7 their parents that it does not meet the requirements of the 8 Michigan merit standard under this section and section 1278b but is 9 a designated specialty school that is exempt from some of those 10 requirements and that a pupil who enrolls in the high school and 11 subsequently transfers to a high school that is not a specialty 12 school meeting the requirements of this subsection will be required 13 to comply with the requirements of the Michigan merit standard

under this section and section 1278b.

- (b) For the most recent year for which the data are available, the mean scores on both the mathematics and science portions of the applicable state assessment for the pupils of the high school exceed by at least 10% the mean scores on the mathematics and science portions of the applicable state assessment for the pupils of the school district in which the greatest number of the pupils of the high school reside.
- (c) For the most recent year for which the data are available,
 the high school had a graduation rate of at least 85%, as
 determined by the department.
 - (d) For the most recent year for which the data are available, at least 75% of the pupils who graduated from the high school the preceding year are enrolled in a postsecondary institution.
- 28 (e) All pupils of the high school are required to meet the 29 mathematics credit requirements of subsection (1)(a)(i), with no

- 1 modification of these requirements under section 1278b(5) -or
 2 section 1278f, as applicable, and each pupil is offered the
 3 curriculum necessary to meet this requirement.
- 4 (f) All pupils of the high school are required to meet the science credit requirements of section 1278b(1)(b) and are also required to successfully complete at least 1 additional science credit, for a total of at least 4 science credits, with no modification of these requirements under section 1278b(5), or section 1278f, as applicable, and each pupil is offered the curriculum necessary to meet this requirement.

- Sec. 1278b. (1) Except as otherwise provided in this section, or section 1278a, or section 1278f, as part of the requirements under section 1278a the board of a school district or board of directors of a public school academy shall not award a high school diploma to a pupil unless the pupil has successfully completed all of the following credit requirements of the Michigan merit standard before graduating from high school:
- (a) At least 4 credits in English language arts that are aligned with subject area content expectations developed by the department and approved by the state board under this section.
- (b) At least 3 credits in science that are aligned with subject area content expectations developed by the department and approved by the state board under this section, including completion of at least biology and either chemistry, physics, anatomy, or agricultural science, or successfully completing a program or curriculum that provides the same content as the chemistry or physics benchmarks, as determined by the department. A student may fulfill the requirement for the third science credit by completing a department-approved computer science program or

- 1 curriculum or formal career and technical education program or
- 2 curriculum. The legislature strongly encourages pupils to complete
- 3 a fourth credit in science, such as forensics, astronomy, Earth
- 4 science, agricultural science, environmental science, geology,
- 5 physics, chemistry, physiology, or microbiology.
- **6** (c) The credit requirements specified in section 1278a(1)(a)(i)
- 7 to (iv).
- **8** (2) If a pupil successfully completes 1 or more of the high
- 9 school credits required under subsection (1) or under section
- 10 1278a(1) or (3) before entering high school, the pupil must be
- 11 given high school credit for that credit.
- 12 (3) For the purposes of this section, and section 1278a, and
- 13 section 1278f, the department shall do all of the following:
- 14 (a) Develop subject area content expectations that apply to
- 15 the credit requirements of the Michigan merit standard that are
- 16 required under subsection (1)(a) and (b) and section 1278a(1)(a)(i)
- 17 and (ii) and the 1/2 credit course in personal finance required
- 18 under section 1278a(3) and develop guidelines for the remaining
- 19 credit requirements of the Michigan merit standard that are
- 20 required under this section and section 1278a(1)(a), for the online
- 21 course or learning experience required under section 1278a(1)(b),
- 22 and for the requirements for a language other than English under
- 23 section 1278a(2). All of the following apply to these subject area
- 24 content expectations and guidelines:
- 25 (i) All subject area content expectations must be consistent
- 26 with the state board recommended model core academic curriculum
- 27 content standards under section 1278. Subject area content
- 28 expectations or guidelines must not include attitudes, beliefs, or
- 29 value systems that are not essential in the legal, economic, and

- 1 social structure of our society and to the personal and social
- 2 responsibility of citizens of our society. The subject area content
- 3 expectations must require pupils to demonstrate critical thinking
- 4 skills.
- 5 (ii) The subject area content expectations and the guidelines 6 must be approved by the state board under subsection (4).
- 7 (iii) The subject area content expectations must state in clear
- 8 and measurable terms what pupils are expected to know upon
- 9 completion of each credit.
- 10 (iv) The department shall complete the development of the
- 11 subject area content expectations that apply to algebra I and the
- 12 guidelines for the online course or learning experience under
- 13 section 1278a(1)(b) not later than August 1, 2006.
- 14 (v) The department shall complete development of the subject
- 15 area content expectations or guidelines that apply to each of the
- 16 other credits required in the Michigan merit standard under
- 17 subsection (1) and section 1278a(1)(a) not later than 1 year before
- 18 the beginning of the school year in which a pupil entering high
- 19 school in 2007 would normally be expected to complete the credit.
- 20 (vi) If the department has not completed development of the
- 21 subject area content expectations that apply to a particular credit
- 22 required in the Michigan merit standard under subsection (1) or
- 23 section 1278a(1)(a) by the date required under this subdivision, a
- 24 school district or public school academy may align the content of
- 25 the credit with locally adopted standards.
- 26 (vii) Until all of the subject area content expectations and
- 27 quidelines have been developed by the department and approved by
- 28 the state board, the department shall submit a report at least
- 29 every 6 months to the senate and house standing committees

- 1 responsible for education legislation on the status of the
- 2 development of the subject area content expectations and
- 3 guidelines. The report must detail any failure by the department to
- 4 meet a deadline established under subparagraph (iv) or (v) and the
- 5 reasons for that failure.
- 6 (b) Develop and implement a process for developing the subject
- 7 area content expectations and guidelines required under this
- 8 section. This process must provide for all of the following:
- 9 (i) Soliciting input from all of the following groups:
- 10 (A) Recognized experts in the relevant subject areas.
- 11 (B) Representatives from 4-year colleges or universities,
- 12 community colleges, and other postsecondary institutions.
- 13 (C) Teachers, administrators, and school personnel who have
- 14 specialized knowledge of the subject area.
- 15 (D) Representatives from the business community.
- 16 (E) Representatives from vocational and career and technical
- 17 education providers.
- 18 (F) Government officials, including officials from the
- 19 legislature.
- 20 (G) Parents of public school pupils.
- 21 (ii) A review of the subject area content expectations or
- 22 guidelines by national experts.
- 23 (iii) An opportunity for the public to review and provide input
- 24 on the proposed subject area content expectations or guidelines
- 25 before they are submitted to the state board for approval. The time
- 26 period allowed for this review and input must be at least 15
- 27 business days.
- 28 (c) Determine the basic level of technology and internet
- 29 access required for pupils to complete the online course or

- 1 learning experience requirement of section 1278a(1)(b), and submit
- 2 that determination to the state board for approval.
- 3 (d) Develop and make available material to assist school
- 4 districts and public school academies in implementing the
- 5 requirements of this section, and section 1278a, and section 1278f.
- 6 This must include developing guidelines for alternative
- 7 instructional delivery methods as described in subsection (7).
- **8** (4) The state board shall approve subject area content
- 9 expectations and guidelines developed by the department under
- 10 subsection (3) before those subject area content expectations and
- 11 guidelines may take effect. The state board also shall approve the
- 12 basic level of technology and internet access required for pupils
- 13 to complete the online course or learning experience requirement of
- **14** section 1278a(1)(b).
- 15 (5) The Lastly applying to pupils entering grade 8 in 2022,
- 16 the parent or legal guardian of a pupil who has completed grade 9,
- 17 a teacher who is currently teaching the pupil, who currently
- 18 teaches in or whose expertise is in a subject area proposed to be
- 19 modified by the personal curriculum, or who is determined by the
- 20 principal to have qualifications otherwise relevant to developing a
- 21 personal curriculum, or a school counselor or school employee
- 22 qualified to act in a counseling role under section 1233 or 1233a
- 23 may request a personal curriculum under this subsection for the
- 24 pupil that modifies certain of the Michigan merit standard
- 25 requirements under subsection (1) or section 1278a(1)(a). If the
- 26 request for a personal curriculum is made by the pupil's parent or
- 27 legal guardian or, if the pupil is at least age 18 or is an
- 28 emancipated minor, by the pupil, the school district or public
- 29 school academy shall develop a personal curriculum for the pupil. A

- 1 teacher, school counselor, or school employee qualified to act in a
- 2 counseling role under section 1233 or 1233a may contact a pupil's
- 3 parent or legal guardian to discuss the possibility and potential
- 4 benefits of a personal curriculum under this subsection for the
- 5 pupil. If Lastly applying to pupils entering grade 8 in 2022, if
- 6 all of the requirements under this subsection for completing a
- 7 personal curriculum are met, then the board of a school district or
- 8 board of directors of a public school academy may award a high
- 9 school diploma to a pupil who successfully completes his or her
- 10 personal curriculum even if it does not meet the requirements of
- 11 the Michigan merit standard required under subsection (1) and
- 12 section 1278a(1)(a). All of the following apply to a personal
- 13 curriculum under this section:
- 14 (a) The personal curriculum must be developed by a group that
- 15 includes at least the pupil, at least 1 of the pupil's parents or
- 16 the pupil's legal guardian, and a teacher described in this
- 17 subdivision or the pupil's high school counselor or another
- 18 designee qualified to act in a counseling role under section 1233
- 19 or 1233a selected by the high school principal. In addition, for a
- 20 pupil who receives special education services, a school
- 21 psychologist should also be included in this group. The teacher
- 22 included in the group developing the personal curriculum must be a
- 23 teacher who is currently teaching the pupil, who currently teaches
- 24 in or whose expertise is in a subject area being modified by the
- 25 personal curriculum, or who is determined by the principal to have
- 26 qualifications otherwise relevant to the group. This subdivision
- 27 does not require an in-person meeting of the group.
- 28 (b) The personal curriculum must do all of the following:
- 29 (i) Incorporate as much of the subject area content

- 1 expectations of the Michigan merit standard required under
- 2 subsection (1) and section 1278a(1)(a) as is practicable for the
- 3 pupil.
- $oldsymbol{4}$ (ii) Establish measurable goals that the pupil must achieve
- 5 while enrolled in high school.
- 6 (iii) Provide a method to evaluate whether the pupil achieved
- 7 the goals described in subparagraph (ii).
- 8 (iv) Align with the pupil's educational development plan
- 9 developed under subsection (11).
- 10 (c) Before it takes effect, the personal curriculum must be
- 11 agreed to by the pupil's parent or legal quardian and by the
- 12 superintendent of the school district or chief executive of the
- 13 public school academy or his or her designee.
- 14 (d) The pupil's parent or legal guardian shall communicate
- 15 with each of the pupil's teachers to monitor the pupil's progress
- 16 toward the goals contained in the pupil's personal curriculum.
- 17 (e) Revisions may be made in the personal curriculum if the
- 18 revisions are developed and agreed to in the same manner as the
- 19 original personal curriculum.
- 20 (f) The English language arts credit requirements of
- 21 subsection (1)(a) and the science credit requirements of subsection
- 22 (1) (b) are not subject to modification as part of a personal
- 23 curriculum under this subsection.
- 24 (q) The mathematics credit requirements of section
- 25 1278a(1)(a)(i) may be modified as part of a personal curriculum if
- 26 the pupil successfully completes at least 3-1/2 total credits of
- 27 the mathematics credits required under that section before
- 28 completing high school, including algebra I and geometry, and
- 29 successfully completes at least 1 mathematics credit during his or

- 1 her final 2 years of high school. The algebra II credit required
- 2 under that section may be modified as part of a personal curriculum
- 3 under this subsection if the pupil meets 1 or more of the
- 4 following:
- $\mathbf{5}$ (i) Successfully completes the same content as 1 semester of
- 6 algebra II, as determined by the department.
- 7 (ii) Elects to complete the same content as algebra II over 2
- 8 years, with a credit awarded for each of those 2 years, and
- 9 successfully completes that content.
- 10 (iii) Enrolls in a formal career and technical education program
- 11 or curriculum and in that program or curriculum successfully
- 12 completes the same content as the algebra II benchmarks assessed on
- 13 the department-prescribed state high school assessment, as
- 14 determined by the department.
- 15 (iv) Successfully completes 1 semester of statistics, functions
- 16 and data analysis, or technical mathematics.
- 17 (h) The social science credit requirements of section
- 18 1278a(1)(a)(ii) may be modified as part of a personal curriculum
- 19 only if all of the following are met:
- 20 (i) The pupil has successfully completed 2 credits of the
- 21 social science credits required under section 1278a(1), including
- 22 the civics course described in section 1166(2).
- (ii) The modification requires the pupil to complete 1
- 24 additional credit in English language arts, mathematics, or science
- 25 or 1 additional credit in a language other than English, or
- 26 requires the pupil to complete a formal career and technical
- 27 education program. This additional credit must be is in addition to
- 28 the number of those credits otherwise required under subsection (1)
- 29 and section 1278a(1) or under section 1278a(2).

(i) The health and physical education credit requirement under section 1278a(1)(a)(iii) may be modified as part of a personal curriculum only if the modification requires the pupil to complete 1 additional credit in English language arts, mathematics, or science or 1 additional credit in a language other than English, or requires the pupil to complete a formal state-approved career and technical education program. This additional credit must be is in addition to the number of those credits otherwise required under subsection (1) and section 1278a(1) or under section 1278a(2).

- (j) The visual arts, performing arts, or applied arts credit requirement under section 1278a(1)(a)(iv) may be modified as part of a personal curriculum only if the modification requires the pupil to complete 1 additional credit in English language arts, mathematics, or science or 1 additional credit in a language other than English, or requires the pupil to complete a formal state-approved career and technical education program. This additional credit must be is in addition to the number of those credits otherwise required under subsection (1) and section 1278a(1) or under section 1278a(2).
- (k) If the parent or legal guardian of a pupil requests as part of the pupil's personal curriculum a modification of the Michigan merit standard requirements that would not otherwise be allowed under this section and demonstrates that the modification is necessary because the pupil is a child with a disability, the school district or public school academy may allow that additional modification to the extent necessary because of the pupil's disability if the group under subdivision (a) determines that the modification is consistent with both the pupil's educational development plan under subsection (11) and the pupil's

- 1 individualized education program. If the superintendent of public
- 2 instruction has reason to believe that a school district or a
- 3 public school academy is allowing modifications inconsistent with
- 4 the requirements of this subdivision, the superintendent of public
- 5 instruction shall monitor the school district or public school
- 6 academy to ensure that the school district's or public school
- 7 academy's policies, procedures, and practices are in compliance
- 8 with the requirements for additional modifications under this
- 9 subdivision. As used in this subdivision, "child with a disability"
- 10 means that term as defined in 20 USC 1401.
- 11 (1) If a pupil transfers to a school district or public school
- 12 academy from out of state or from a nonpublic school, the pupil's
- 13 parent or legal guardian may request, as part of the pupil's
- 14 personal curriculum, a modification of the Michigan merit standard
- 15 requirements that would not otherwise be allowed under this
- 16 section. The school district or public school academy may allow
- 17 this additional modification for a transfer pupil if all of the
- 18 following are met:
- 19 (i) The transfer pupil has successfully completed at least the

- 19 legal guardians by sending a written notice to each pupil's home or
- 20 by including the notice in a newsletter, student handbook, or
- 21 similar communication that is sent to a pupil's home, and also
- 22 shall post the notice on the school district's or public school
- 23 academy's website.
- 24 (o) A pupil's twenty-first century skills curriculum must be
- 25 aligned with the pupil's educational development plan under section
- 26 1278b(11) and must be designed so as to allow the pupil to
- 27 incorporate his or her twenty-first century skills curriculum into
- 28 his or her educational development plan under section 1278b(11).
- 29 (p) A pupil who modifies certain credit requirements through a

- 1 twenty-first century skills curriculum under subdivision (f) must
- 2 still be required to complete the civics course described in
- 3 section 1166(2).
- 4 (2) The department, in conjunction with the department of
- 5 labor and economic opportunity and stakeholder groups, shall
- 6 develop and make available to all school districts and public
- 7 school academies model information materials that school districts
- 8 and public school academies may use to implement and streamline the
- 9 twenty-first century skills-curriculum-development process under
- 10 this section. These materials must be posted on the department's
- 11 website and must be made widely available to the parents and legal
- 12 guardians of pupils, pupils, teachers, school counselors, and other
- 13 school district and public school academy employees. It is the
- 14 intent of the legislature that the materials described in this
- 15 subsection be designed to assist the parents and legal guardians of
- 16 pupils, pupils, and public schools to more easily develop a twenty-
- 17 first century skills curriculum under this section. At a minimum,
- 18 the materials described in this subsection must include models for
- 19 all of the following:
- 20 (a) Incorporating a pupil's twenty-first century skills
- 21 curriculum into his or her educational development plan as provided
- 22 under subsection (1)(o).
- 23 (b) Integrating the process of developing a twenty-first
- 24 century skills curriculum under this section into a school's
- 25 standard course-scheduling process and the annual educational
- 26 development plan review and revision process required under section
- 27 1278b(11).
- (c) Pathways that provide school districts and public school
- 29 academies with the most commonly utilized educational tracks for

1 pupils to adopt as their twenty-first century skills curriculum.
