## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 103. (1) An Except as otherwise provided in subsection
- 2 (2), an agency may purchase obtain and possess an opioid antagonist
- 3 for purposes of this act and distribute that opioid antagonist to
- 4 an employee or agent who has been trained in the administration of
- 5 that opioid antagonist for purposes of this act.

- (2) Beginning 6 months after the effective date of the 1 amendatory act that added this subsection or beginning the first 2 3 school year that begins after the effective date of the amendatory act that added this subsection, whichever is later, an agency that 4 is a school district shall obtain an opioid antagonist for purposes 5 6 of this act and distribute that opioid antagonist to each school 7 within the school district that offers any of grades K to 5, and to 8 an employee or agent of the schools described in this subsection.
- 9 Sec. 105. (1) An employee or agent may possess an opioid 10 antagonist distributed to that employee or agent under section 103 11 and may administer that opioid antagonist to an individual if both 12 of the following apply:
- (a) The employee or agent has been trained in the properadministration of that opioid antagonist.
- 15 (b) The employee or agent has reason to believe that the 16 individual is experiencing an opioid-related overdose.
- 17 (2) An agency described in section 103(2) shall ensure that an 18 employee or agent of that agency is trained in the manner described 19 in this section.
