

HOUSE BILL NO. 5034

September 26, 2023, Introduced by Reps. Phil Green, Johnsen, Slagh, Jaime Greene and BeGole and referred to the Committee on Government Operations.

A bill to amend 2013 PA 240, entitled "Michigan state capitol historic site act," by amending section 6 (MCL 4.1946).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 6. (1) The commission shall do all of the following:
- 2 (a) Subject to ~~subsection~~**subsections** (2) **and (3)**, operate and
- 3 manage the Michigan ~~state capitol historic site~~**.State Capitol**
- 4 **Historic Site.**
- 5 (b) Maintain and restore the ~~state capitol building~~**.State**
- 6 **Capitol Building.**

1 (c) Maintain and improve the grounds of the Michigan ~~state~~
2 ~~capitol historic site.~~ **State Capitol Historic Site.**

3 (d) Appoint an individual to manage the day-to-day operations
4 of the Michigan ~~state capitol historic site.~~ **State Capitol Historic**
5 **Site.** The individual appointed under this subdivision is an at-will
6 employee and ~~shall serve~~ **serves** at the pleasure of the commission.

7 (e) Employ staff to carry out the commission's
8 responsibilities under **this** subsection ~~(1)~~ and as otherwise
9 provided by law. All individuals employed by the commission are
10 nontenured, at-will employees. The commission may discipline,
11 transfer, demote, suspend, or summarily discharge an employee.

12 (f) Contract with any person for purposes of procuring goods
13 or services or otherwise carrying out the commission's
14 responsibilities with regard to the Michigan ~~state capitol historic~~
15 ~~site.~~ **State Capitol Historic Site.**

16 (g) Make recommendations to the governor, the senate, and the
17 house of representatives regarding funding for the Michigan ~~state~~
18 ~~capitol historic site,~~ **State Capitol Historic Site,** including, but
19 not limited to, funding from the fund.

20 (h) Carry out other responsibilities as provided by law.

21 (2) The commission does not have authority and shall not
22 exercise control over the internal decisions of the senate or the
23 house of representatives related to the allocation of space in the
24 ~~state capitol building~~ **State Capitol Building** or the ~~state capitol~~
25 ~~building~~ **State Capitol Building** parking lot, including legislative
26 or staff offices. All decisions concerning space in the ~~state~~
27 ~~capitol building~~ **State Capitol Building** and the ~~state capitol~~
28 ~~building~~ **State Capitol Building** parking lot ~~shall~~ **must** be made
29 according to the rules or practices of the senate and the house of

1 representatives.

2 (3) The commission does not have authority over and shall not
3 regulate the conduct of a member of the legislature, and may not
4 prevent a member of the legislature from entering the State Capitol
5 Building.
