(MCL 408.471 to 408.490) by adding section 13b; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 13b. (1) Except as otherwise provided in subsection (2),
- 2 an employer shall not pay wages to an employee at a rate that is
- 3 different than the rate the employer pays wages to another employee
- 4 for equal work on jobs, the performance of which requires equal
- 5 skill, effort, and responsibility and that is performed under
- 6 similar working conditions, because of a protected attribute or
- 7 characteristic of the employee.
- 8 (2) An employer does not violate subsection (1) if the
- 9 employer pays wages at a rate in accordance with 1 or more of the
- 10 following:
- 11 (a) A seniority system.
- 12 (b) A merit system.
- 13 (c) A system that measures earnings by quantity or quality of
- 14 production.
- 15 (d) A factor other than a protected attribute or
- 16 characteristic.
- 17 (3) An employer that violates subsection (1) shall not reduce
- 18 the rate at which it pays wages to an employee to comply with
- 19 subsection (1).
- 20 (4) As used in this section, "protected attribute or
- 21 characteristic" means the religion, race, color, national origin,
- 22 age, sex, sexual orientation, gender identity or expression,
- 23 height, weight, marital status, or any other attribute or
- 24 characteristic of an individual that is protected under the Elliot-
- 25 Larsen civil rights act, 1976 PA 453, MCL 37.2101 to 37.2804.
