 2 health profession subfield license under this part, or who is
 3 authorized under section 17820b to engage in practice as a physical
 4 therapist assistant, who assists a physical therapist in physical
 5 therapy intervention.
 - (c) "Physical therapy licensure compact" means the physical therapy licensure compact as enacted in section 16188.

- (d) (e)—"Practice as physical therapist assistant" means the practice of physical therapy performed under the supervision of a physical therapist licensed under this part.
- 10 11 (e) (d) "Practice of physical therapy" means the evaluation of, education of, consultation with, or treatment of an individual 12 by the employment of effective properties of physical measures and 13 14 the use of therapeutic exercises and rehabilitative procedures, 15 with or without assistive devices, for the purpose of preventing, correcting, or alleviating a physical or mental disability. 16 Physical therapy includes treatment planning, performance of tests 17 and measurements, interpretation of referrals, initiation of 18 referrals, instruction, consultative services, and supervision of 19 20 personnel.
