#### **House Resolution No. 260.**

A resolution to declare May 12-18, 2024, as Police Week in the state of Michigan.

Whereas, In 1962, President Kennedy proclaimed May 15 as National Peace Officers Memorial Day and the calendar week in which May 15 falls as National Police Week. Established by a joint resolution of Congress in 1962, National Police Week pays special recognition to those law enforcement officers who have lost their lives in the line of duty for the safety and protection of others; and

Whereas, There are more than 800,000 law enforcement officers serving in communities across the United States, including the approximately 17,000 full-time uniformed police officers in Michigan. These dedicated individuals serve in more than six hundred state, county, and local departments; and

Whereas, Members of law enforcement deserve the appreciation and respect of the people of Michigan for the merit, dignity, bravery, and reliability they exhibit each and every day. We must also honor the sacrifices made by families of police officers, as each day they must face constant fear as their loved one works to protect us; and

Whereas, In 2023 alone, 136 law enforcement officers were killed in the line of duty across the country. The names of these dedicated public servants are engraved on the walls of the National Law Enforcement Officers Memorial in Washington, D.C.; and

Whereas, Michigan's fallen officers will never be forgotten, nor will their service to their respective communities. By choosing to commit themselves to law enforcement, these brave individuals answered the call for service and willingly put their lives in jeopardy. We commend them for recognizing service as a noble career, and protecting the public safety; and

Whereas, Michigan citizens have turned to members of law enforcement for assistance and support in times of distress, whether they are coping with a personal crisis, or struggling through civil disorder or a natural disaster. Our communities rely on these courageous individuals when it is difficult to stand on our own, and we are indebted to the unwavering public service of our local and state police. We are indeed fortunate and grateful for the contributions of law enforcement officers to the people of this state; now, therefore, be it

Resolved by the House of Representatives, That the members of this legislative body declare May 12-18, 2024, as Police Week in the state of Michigan. We publicly salute the service of law enforcement officers in our state and nation and honor police who place their lives on the line for the safety and security of their communities.

Whereas, Klinefelter syndrome (KS or 47,XXY) is a genetic condition affecting males, characterized by an extra X chromosome; and

Whereas, Individuals with Klinefelter syndrome exhibit a wide spectrum of disabilities and struggles, yet these individuals also possess abilities and strengths, contributing positively to our communities; and

Whereas, Early diagnosis and appropriate support can significantly enhance the quality of life for individuals with Klinefelter syndrome from childhood to adulthood; and

Whereas, With increased awareness and understanding, we can create a more inclusive and supportive environment for those living with Klinefelter syndrome; and

Whereas, Families and caregivers play a crucial role in the well-being of individuals with Klinefelter syndrome, providing love, support, and advocacy; and

Whereas, Although 1 in 500 men are born with Klinefelter syndrome, only 35% will receive an official diagnosis; and

Whereas, There is no cure for Klinefelter syndrome; and

Whereas, Advancements in medical and therapeutic interventions offer promising avenues for managing symptoms and improving the overall health and well-being of individuals with Klinefelter syndrome; and

Whereas, Testosterone replacement therapy, educational and behavioral support, occupational therapy, physical therapy, and other interventions can help individuals with Klinefelter syndrome reach their full potential; and

Whereas, The American Association for Klinefelter Syndrome, and the Living with XXY Organization offer valuable resources and support for individuals and families affected by Klinefelter syndrome; and

Whereas, By recognizing May as Klinefelter Syndrome Awareness Day, we honor the resilience, strength, and contributions of individuals with Klinefelter syndrome and pledge to continue supporting research and initiatives that improve their quality of life; now, therefore, be it

Resolved by the House of Representatives, That the members of this legislative body declare May 2024 as Klinefelter Syndrome Awareness Day in the state of Michigan. We celebrate the diversity of our community and reaffirm our commitment to promoting inclusivity and support for individuals with Klinefelter syndrome.

#### House Resolution No. 262.

A resolution to commemorate the 70th anniversary of the *Brown v. Board of Education* Supreme Court decision.

Whereas, On May 17, 2024, the nation will mark the 70th anniversary of the U.S. Supreme Court’s ruling in *Brown v. Board of Education*, in which the court unanimously decided that “in the field of public education, the doctrine ‘separate but equal’ has no place. Separate educational facilities are inherently unequal”; and

Whereas, The *Brown v. Board of Education* ruling was a triumphant civil rights victory following decades of litigation and fights to end state-sponsored segregation in U.S. public schools and provided hope and inspiration to those involved in the struggle for racial equality in the United States; and

Whereas, The ruling energized the then-fledgling civil rights movement, opened the door to and gave a legal basis for ending centuries of racial segregation, and is widely recognized as one of the most pivotal U.S. Supreme Court rulings of the 20th century; and

Whereas, The historic decision repudiated the doctrine of “separate but equal” ruling that separate educational systems, by their very nature, could not be equal. It must be noted that many areas of our nation are still struggling with the vestiges of segregation and many students are still not afforded equal opportunities in public education and the larger society; and

Whereas, The challenge of racial equality continues as we must work to build a society in which differences are embraced and opportunities made equally available, a society enriched by racial diversity, not segregated by it, and that we do all we can to build a society that will leave no one behind; now, therefore, be it

Resolved by the House of Representatives, That the members of this legislative body commemorate the 70th anniversary of the *Brown v. Board of Education* Supreme Court decision. We encourage Michiganders to dedicate time engaging each other on the importance of this Supreme Court decision and its impact on equal opportunity in public education and the larger society.
